

FORM W-9 Request for Taxpayer Identification Number and Certification

Dobbs Equipment Southeast, LLC (FEIN: 88-2976622) is a single member limited liability company (LLC) wholly-owned by DJD Equipment Holdings, LLC. For Federal income tax purposes, Dobbs Equipment Southeast, LLC is considered a “disregarded entity”, separate from its owner, DJD Equipment Holdings, LLC (FEIN: 82-2518859). All of the activities of Dobbs Equipment Southeast, LLC are reported within the Federal income tax return of DJD Equipment Holdings, LLC.

In accordance with Form W-9 instructions, the “Name” and employer identification number must be the name shown on the Federal income tax return on which the income is reported. The name of the entity entered on the “Name” line of the Form W-9 should never be a disregarded entity. The name of the disregarded entity should be included on the line immediately below.

Form W-9 has been prepared using the entity name and employer identification number of DJD Equipment Holdings, LLC as required.

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
 - Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
 - Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
 - Form 1099-S (proceeds from real estate transactions)
 - Form 1099-K (merchant card and third party network transactions)
 - Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
 - Form 1099-C (canceled debt)
 - Form 1099-A (acquisition or abandonment of secured property)
- Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.
- If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.*
