PURPOSE:

To consider accepting -\$101,992.00 for the DeKalb County Adult Felony Drug Court from the Criminal Justice Coordinating Council and appropriating the amount to a new Grant Fund.

NEED/IMPACT:

The Criminal Justice Coordinating Council has awarded -\$101,992.00 to the DeKalb County Adult Felony Drug Court. Funding will be used toward annual conference, psychiatric & nursing services, counseling & peer support services, medication, drug testing & monitoring supplies, for program participants. The grant period is from July 1, 2025 through June 30, 2026. The required cash match (\$17,99.00) will be met through the Superior Court Operating budget

FISCAL IMPACT:

Funding for all services provided by Criminal Justice Coordinating Council Grant in the amount of \$101,992.00. Funding must be spent by June 30, 2025, end of State FY 2026
