 - A. New Panel including feeders to existing transformer.
 - B. New Contactors for each pole in Musco supplied LCC control cabinet.
 - C. New low voltage transformer and low voltage panel including wiring.
 - D. New wiring from contactor cabinet to cabinets on individual poles.
 - E. Repair and replace underground j-boxes as required.
 - F. Repair and replace wiring, light, receptacle and switch at Scorer stand.
Repair receptacles at batting cages. Repair Irrigation receptacles and Security lighting on A poles.
