PURPOSE:

To consider authorizing addition to the fleet of three vehicles via the District Attorney's Asset Forfeiture funds; and

NEED/IMPACT:

The District Attorney's Office has fourteen aging pool cars that were previously in the vehicle replacement plan and have now moved to surplus. This has begun to pose a safety hazard for investigators utilizing the vehicles in the normal course of their job responsibilities, and there is no current avenue for the cars' replacement.

PURPOSE:

To transfer \$85,000.00 from 2006 Parks Bond account 104246.80461.541200.01.601733 to fund a grant match for Briarlake Forest Park.

NEED/IMPACT:

This funding is needed to match a Park Pride grant secured by the Friends of Briarlake Forest Park. Total cost of the project is \$140,000.00 with the following funding sources:

-	Park Pride Grant	\$50,000
-	DeKalb County 2006 Parks Bond Match	\$85,000
_	Park Pride Account	\$5,000

The funds will be used to implement phase one of the master plan that would include construction of circulation trail, installation of fountain and utilities, build parking area and installation of signage and split rail fence at entrance of park.

RECOMMENDATION(S):

Recommend that funds in the amount of \$85,000.00 be transferred from 2006 Parks Bond account 104246.80461.541200.01.601733 to fund a grant match for Briarlake Forest Park; and authorize the Chief Executive Officer to execute all the necessary documents and contracts for the completion of the project.
