PURPOSE:

To request sponsorship to authorize the Legislative and Congressional Reapportionment Office of the General Assembly to review the proposed redistricting plan as required under O.C.G.A. § 28-1-14.1(b)(3)(A), which plan is reflected in the enclosed Exhibit A (for DeKalb County Board of Commissioners Districts 1-5) and Exhibit B (for DeKalb County Board Commissioners Districts 6-7), consistent with the number of districts set out in the DeKalb County Organizational Act. See Ga. L. 1981, p. 4304, § 1; Ga. L. 1982, p. 4235, § 1; Ga. L. 1992, H.B. 1577, § 1; Ga. L. 1992, p. 6566, § 1; Ga. L. 2002, p. 3544, § 1; Ga. NEED/IMPACT:

Pursuant to O.C.G.A. § 28-1-14.1, review by the Legislative and Congressional Reapportionment Office is required before the redistricting plan can be adopted by the Governing Authority and prior to the introduction of legislation to implement the plan.

To approve the resolution and request that the DeKalb County Delegation to the Georgia House of Representatives authorize the LCRO to review the proposed redistricting plan as required under O.C.G.A. § 28-1-14.1(b)(3)(A), which plan is reflected in Exhibit A (for DeKalb County Board of Commissioners Districts 1-5) and Exhibit B (for DeKalb County Board Commissioners Districts 6-7), consistent with the number of districts set out in the DeKalb County Organizational Act. RESOLUTION

A RESOLUTION OF THE GOVERNING AUTHORITY OF DEKALB COUNTY, GEORGIA TO THE DEKALB COUNTY DELEGATION OF THE GENERAL ASSEMBLY TO AUTHORIZE THE LEGISLATIVE AND CONGRESSIONAL REAPPORTIONMENT OFFICE TO REVIEW PROPOSED DISTRICT MAPS

WHEREAS, every ten years based on the federal census data, district boundaries for elected offices are redrawn as necessary to ensure equal representation of a jurisdictional population;

WHEREAS, the DeKalb County GIS Department has analyzed the 2020 census data for Dekalb County and created options for new district maps that provide a more equal distribution of the population than the current maps for the Commission districts;

WHEREAS, the Board of Commissioners has evaluated these options and determined that the maps attached hereto satisfy legal requirements and traditional principles for redistricting and would best serve the interests of the people of DeKalb County;

WHEREAS, in 2019 the General Assembly passed O.C.G.A. § 28-1-14.1, which requires the General Assembly's Legislative and Congressional Reapportionment Office (the "LCRO") to review and approve a proposed redistricting plan for a county board of commissioners prior to the adoption of the plan by the Board of Commissioners and prior to the introduction of the local legislation to implement the new plan;


WHEREAS, pursuant to O.C.G.A. § 28-1-14.1(b)(3)(A), the LCRO review requires a letter of sponsorship from a member of the General Assembly who represents the area in which the Board of Commissioners is located, either in whole or in part, authorizing the LCRO staff to review the proposed redistricting plan;

NOW, THEREFORE BE IT RESOLVED BY THE COUNTY GOVERNING AUTHORITY IN THE STATE OF GEORGIA, AS FOLLOWS:

The Governing Authority of DeKalb County requests that the DeKalb County Delegation to the General Assembly authorize the LCRO to review the proposed redistricting plan as required under O.C.G.A. § 28-1-14.1(b)(3)(A), which plan is reflected in the attached Exhibit A (for DeKalb County Board of Commissioners Districts 1-5) and Exhibit B (for DeKalb County Board Commissioners Districts 6-7), consistent with the number of districts set out in the DeKalb County Organizational Act. 
