Benefits include health, dental and life insurance. The PAT Supervisor will oversee the work at the agency level and hold the PAT staff accountable for the day-to-day work of PAT, including bi-monthly supervisory meetings to review families and monthly PAT staff meetings. In addition, the PAT Supervisor will work to ensure that the essential requirements for PAT are met by the agency and participate in Georgia Home Visiting Programs network and PAT training. The PAT Supervisor* is a .50 FTE position. Note that the PAT Supervisor for this site is also the First Steps Community Screener, earning \$17,500, (\$1458.33 monthly), listed under contractual expenses. Scottdale Early Learning will contract with DeKalb County and will be responsible for completing the core screening instrument, and linking families to evidenced based home visiting or community services for the First Steps Program. A minimum of 25 screens are required per month (300 per year) to meet the goal of a minimum of 1000 screens per year. As a contract position, no taxes or benefits are included.

			The Community Screener Organization is a community agency that will be in contract with DeKalb County and will be responsible for completing the core screening instrument and linking families to evidenced based home visiting or community services.	The contracted amount is estimated at \$27,540, (\$2295.00 monthly). A minimum of 34 screens are required per month (408 per year) to meet the goal of a minimum of 1000 screens per year. As a contract position, no taxes or benefits are included. Local and long-distance travel includes using personal vehicles for site visits and required meetings-\$1000 for REACH.

			The DeKalb County Board of Commissioners has requested more impact data that specifically reports DeKalb County outcomes related to the MIECHV and First Steps Programs. These funds will be used to contract with an evaluator to provide data that will be shared with the state. The evaluator will be responsible for collecting data from GEHOVIS, measuring impacts on DeKalb County and creating a presentation that outlines the findings. These evaluation efforts are aimed to garner more support for the HV/FS Programs in the future from DeKalb County Key Stakeholders.
