Awarded by the BOC on September 25, 2018 for an amount not to exceed \$468,000.00. On December 14, 2021, the BOC approved Change Order No. 1 to increase the contract by an amount not to exceed \$156,000.00 and to extend the contract term to December 31, 2022. On December 13, 2022, the BOC approved Change Order No. 2 to increase the contract by an amount not to exceed \$156,000.00 and to extend the contract term to December 31, 2023. On December 12, 2023, the BOC approved Change Order No. 3 to increase the contract funds and term through December 31, 2024 for an amount not to exceed \$156,000.00. This contract consists of providing federal legislative lobbying services. This request is to increase contract funds and term through December 31, 2025.
