

RESOLUTION

AUTHORIZATION TO ACCEPT GDOT CONTRACT FOR COSTS ASSOCIATED WITH AIRPORT PERIMETER FENCING REPLACEMENT; REHABILITATE TAXIWAY K DESIGN; AND RELOCATE TAXIWAY G DESIGN AT THE DEKALB PEACHTREE AIRPORT

WHEREAS, THE DEKALB COUNTY BOARD OF COMMISSIONERS, desires to make improvements to existing DeKalb-Peachtree Airport by soliciting and receiving bids from Delta Specialty Contractors to replace the existing perimeter fencing and Michael Baker International to provide Resident Inspection Construction Administrative Services, Design Services for the project and;

WHEREAS, THE DEKALB COUNTY BOARD OF COMMISSIONERS will receive a contract from the Georgia Department of Transportation (GDOT) contract AP026-9000-59(089) for DeKalb County to provide reimbursement for the costs associated with the above Services up to a maximum amount not to exceed the total estimated cost of \$2,403,521.40 of which up to \$1,802,641.05 will be State Funds and requiring a local match of approximately \$600,880.35 and;
