**Description of Proposed Changes**: The proposed change is to extend the contract time and contract term for an additional 2 years. In the months that the contractor has been working, they have completed approxiately 40% of the work. The estimated completion time based on crew productivity and Wach's estimate of the number of crews available going forward would be fall, 2025, therefore a new completion date of December 31th, 2025 is requested.

**Justification of Proposed Changes**: Despite efforts from the contractor they have not been able to field a sufficient number of crews to do the work. With the current record low unemployment, recruiting new crew has proved difficult. Should Wachs complete the scope of work earlier and should there be budget left, then their services can remain available to the Department on an as needed basis.
