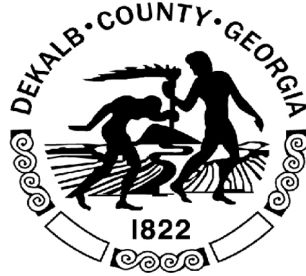

**C. COMMENTS FROM THE PUBLIC**

The purpose of public comment is to allow the public to voice county-related requests, concerns or opinions during the Commission meeting. Speakers will only have the opportunity for one public comment per meeting. Public comments may be made in person or submitted by sending an email no longer than one page to [PublicComments@dekalbcountyga.gov](mailto:PublicComments@dekalbcountyga.gov) which must be received between 9:00 a.m. and 10:00 a.m. on the day of the meeting. Only those emails received during the allotted time may be read aloud. Public comment emails received outside of the allotted time will be included in the public comment record for the next meeting after receipt of those emails. The body of your email must include your first and last name, followed by your address. By submitting an email for public comment at any time, you agree to have your name, address and email entered into the record/minutes. Each in-person speaker must complete a speaker card and present it to the clerk before the beginning of the public comment portion of the meeting.

Cards must be turned in to the clerk from the time the general meeting is convened (generally 9 A.M.) and by the beginning of public comment portion generally following presentations on the agenda. The clerk will accept cards on a first-come, first-served basis. Prior to the clerk's call for public comment, in-person speakers who are residents of DeKalb County shall be allowed to speak before residents of other counties are allowed to speak. Once the public comment portion of the meeting begins, speaker cards will no longer be accepted. Speakers will be allowed to speak for three minutes each and public comment shall not exceed 30 minutes in length. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to yield the podium. Those in-person attendees who submitted speaker cards but did not speak because of the time allotment will be allowed to speak first at the next regularly scheduled Commission meeting without regard to residence. If time remains in the proscribed public comment portion of said meeting, email comments will be read into the record by the clerk or designee. Any remaining email public comments received between 9:00 am and 10:00 a.m. on the day of the meeting not read into the record will be submitted into the minutes by the clerk or designee and shall be forwarded to each commissioner by email. Speakers should always talk directly into the microphone and begin by stating their name, full address and the name of any organization they represent. Abusive, profane or derogatory language, holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.

4. Efia Miles (No Address)- Good morning. I am a 45-year-old woman and a DeKalb County resident for the past 30 years. I'm a product of a large Southern, religious and military family. I am 2nd generation college-educated and have held a professional license as a clinical social worker in the state of Georgia since 2016. I had an abortion when I was 28 and I have never regretted my decision. About a year later, I ended up working at one of the oldest abortion clinics in Atlanta as one of the counselors that patients see just before the procedure. I was tasked with confirming their certainty and recommending that anyone expressing even a modicum of doubt or a change of heart cancel their procedure. I spoke to hundreds of women and girls and no two stories were alike. There were mothers who couldn't afford to feed another child, women frustrated that their insurance plans covered Viagra, but denied coverage for birth control, and others with debilitating medical conditions or substance use disorders or plans to leave an abusive relationship. A significant number were referred by a geneticist or obstetrician who advised of a fetal anomaly or rare genetic mishap that could prove fatal to the patient or the fetus.
  
5. On a day I'll never forget, I sat with a 12-year-old girl in her 2nd trimester of pregnancy, the result of incest. I explained the consent forms to her mother that would give the detective waiting outside permission to retrieve the 'products of conception' for the impending criminal case against the child's own grandfather. Whenever I hear our elected leaders fumbling with their understanding of female anatomy or trying to weaponize religion to justify oppression, I think of that little girl and wonder where she is now. I know beyond the shadow of a doubt that I would not be where I am or who I am today if I had not had the ability to make that important healthcare

decision. Having no agency over my own body could have destroyed my chances of continuing my education and becoming a healthcare provider. It also could have severely limited my earning potential, keeping me from being able to help care for my aging parents and paying more taxes to ensure essential county services continue among other things. I say all the time that you will not find people who identify as being 'ANTI-life' on the other side of the pro-life argument. Taking a stand for women's reproductive rights is the right thing to do and the majority of people in this county, state and country agree. Please vote YES on the Declaration of Reproductive Freedom. 6. Julia Wallace, 385 Kenilworth Circle Stone Mountain Georgia- My name is Julia wallace. My address is 385 Kenilworth Circle Stone Mountain Georgia. Firstly, Please be aware that the email address on today's meeting agenda for submitting public comments is incorrect. I spoke with the receptionist who helped me find the correct email address, but other residents may not be able to submit public comments. Thank you. I want to comment in regards to the text amendment 2022-2271. I have spoken to four people in DeKalb county government, three of which are in planning and sustainability about the meaning and effects of this item. Each person has provided me with a different interpretation and vastly different possible outcomes and effects of this text amendment. I ask you to defer this item to provide more time to clarify the interpretation and scrutinize its effects to ensure a vote of confidence to represent the people of Dekalb County. Thank you.

7. Lea Iodice (No Address)- Abortion care is a part of full spectrum reproductive health care. Decriminalizing abortion can save lives of many people- and no one deserves to be criminalized for seeking essential healthcare. With Georgia being one of the states with the highest maternal mortality rates, abortion care will actually DECREASE these rates- it's imperative for abortion care to be accessible to all people who need it. It should be a decision based on the person seeking care and their doctor.

8. Jane Guthrie, 174 Locust St NE, Atlanta, GA 30317- Dear Board Commissioners, Please vote YES on the Declaration for Reproductive Freedom. As a woman, I want to be able to make decisions about my body and my health without anyone else telling me what to do. It is incredibly unjust to force women to endure unwanted pregnancies. This is a human rights issue!!! There are no laws forcing men to have vasectomies are there? Because there should be. 100% of pregnancies are caused by men. Why are they not held responsible and only women have to suffer? Each of us should be able to live, work, and make decisions about our health and our future with dignity and without fear of criminalization. Dekalb County is one of the largest and most diverse counties in Georgia and as such can play a pivotal role in ensuring that Georgians have access to the full spectrum of reproductive health services, including abortion care. 9. Hayley V. McMahon, MSPH, CPH (No Address)- To the Dekalb County Board of Commissioners: My name is Hayley McMahon, and I am a doctoral student at the Emory Rollins School of Public Health. I hold a Master of Science in Public Health from the Johns Hopkins Bloomberg School of Health and a Certification in Public Health from the National Board of Public Health Examiners. My research focuses on abortion access for marginalized people and the impacts of criminalization. Because this is my specific area of expertise, I can say without a single doubt: Criminalizing abortion hurts public health, and it hurts communities. Dekalb County has an opportunity to mitigate the harms that have been done by ideologically driven legislation, and I urge you to take it by voting YES on the Declaration of Reproductive Freedom. The science on this matter is crystal clear: criminalizing abortion is harmful. It leads to more involuntary births. We know from extensive longitudinal data that being denied wanted abortion care increases a person's likelihood of dying from a pregnancy-associated death, of living in poverty, of being tethered to an abusive partner, of suffering from chronic illnesses, of experiencing poor maternal bonding, and of having children who do not reach childhood development milestones with their peers (Foster et al., 2018; Roberts et al., 2014; Foster et al., 2018b; Foster et al., 2018c; Gerds et al., 2015; Ralph et al., 2019). Self-managed abortion with medication, which many people turn to when abortion is criminalized, is extremely medically safe, but, as you know, legal risks remain (Becker & McMahon, 2022). Between 2000 and 2020, legal experts documented at least 61 cases of a person being arrested or criminally investigated for allegedly self-managing an abortion or helping another person do so in. These arrests and investigations occurred in 26 different states, including Georgia. Criminalization, of course, leads to more people in the jail and prison system, which devours taxpayer money and irreversibly damages families. Low-income people and Black and brown people—who disproportionately make up your Dekalb County constituents—bear the greatest burden of these harms (If/When/How, 2022). I say this with certainty: There is no scientific basis whatsoever for criminalizing abortion. You have the power to realign health policy with scientific evidence and protect your constituents from entirely preventable threats to their health and wellbeing. Again, I urge you to do so by voting YES for a Declaration of Reproductive Freedom. Sincerely,

10. Emily Backus ( No Address)- Hello, My name is Emily Backus and I am a nine-year resident of DeKalb. I chose to live here over other suburbs of Atlanta because of the progressive political climate and diversity of the residents. I am asking the commission to please support the abortion decriminalization bill. Reproductive healthcare is a right that we all deserve, and by supporting this bill you will send a message to your constituents that you respect our right to control our own bodies.

11. O. Winslow Edwards, MPH, 3213 Bobbie Lane, Decatur, GA 30032- To whom it may concern: I am a Dekalb County resident reaching out in support of the Declaration of Reproductive Freedom. Like approximately half of Dekalb County residents, I have a uterus. As such, it is important to me that all Dekalb County residents of reproductive potential have the freedom to make our own choices about our bodies based on whether or not we feel prepared to adequately care for a child. Georgia currently has the highest maternal mortality rate in this country, according to a recent study by GSU. Our state is also 38th in the nation when it comes to child and family wellbeing, according to the 2022 Kids Count. Finally, 18.7% of children in Georgia

live in poverty based on data from the Census Bureau's American Community Survey. In a state with such negative conditions and limited resources available to support maternal and child health, it is unconscionable to restrict access to abortion and other reproductive healthcare. Roe v. Wade has been in effect for essentially my entire lifetime and this recent Supreme Court Decision flies in the face of 49+ years of precedent. I implore you to support your fellow Dekalb County residents' reproductive rights by passing the Declaration of Reproductive Freedom. Thank you for doing the right thing.

12. Allison Coffman, 120 Howard Street SE Atlanta, GA 30317- Hello, My name is Allison Coffman. I live at 120 Howard Street SE Atlanta, GA 30317 and am a Dekalb resident. Thank you to the ERPS committee for unanimously voting in favor of the resolution for reproductive freedom. This resolution is desperately needed. With Georgia's early abortion ban, Georgians are at increased risk for criminalization for their reproductive health decisions. **D. 10:00 A.M. PUBLIC HEARING**

Citizens may speak for or against an item that is considered by law to be a zoning ordinance and each side will have ten minutes to present its case. Citizens may also speak for or against an item that is placed on the public hearing agenda but is not a zoning ordinance. In that case, each side will have five minutes to present its case. In the event there is more than one speaker per side, speakers must divide their time in order to complete their full presentation within the ten-minute time allotment, or the five minute time allotment. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to leave the podium area. Citizens may also email statements or documents related to public hearing items for inclusion in the public record by submitting such statements or materials by 9:00 a.m. on the date of the public hearing to [PublicHearing@dekalbcountyga.gov](mailto:PublicHearing@dekalbcountyga.gov). The body of your email must include a reference to the particular public hearing item to which your statement or documents apply by agenda number and your first and last name, followed by your address. By submitting an email related to any public hearing item, you agree to have your name, address and email entered into the record/minutes. In-person comments will be heard first. Prior to speaking, an in-person speaker shall complete a speaker card and present it when approaching the podium. If an in-person speaker has any documents for the commissioners, the speaker shall provide 10 copies when approaching the podium. Seven copies are for the commissioners and the remaining copies are for the planning director, the county attorney and the clerk. In all zoning ordinance and traffic calming cases, staff shall make their recommendation for action to the Commission first followed by applicants or citizens speaking in favor of the item. Applicants in zoning ordinance cases shall have the right to reserve time for rebuttal. Opponents of a zoning ordinance item shall have no right of rebuttal. For all other items placed on the public hearing agenda, applicants or citizens speaking in favor of the item shall speak first followed by opponents of the item.

If time remains in the appropriate public hearing portion of said meeting, email comments will be read into the record by the clerk or designee. If time remains in the appropriate public hearing portion of said meeting, email comments will be read into the record by the clerk or designee. Any remaining email public comments not read into the record will be submitted into the minutes by the clerk or designee and shall be forwarded to each commissioner by email. Once the citizens have finished speaking, staff shall make a recommendation for action to the Commission. At this point, citizens are no longer allowed to speak unless called to the podium by an individual commissioner to answer questions or provide information. In-person Speakers should always talk directly into the microphone and begin by stating their name, address and the name of any organization they represent. Abusive, profane or derogatory language will not be permitted. Holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.
