

RESOLUTION

AUTHORIZATION TO ACCEPT GDOT CONTRACT FOR COSTS ASSOCIATED WITH PROJECT FOR AIRFIELD CRACK SEAL & REMARKING AT THE DEKALB PEACHTREE (PDK) AIRPORT

WHEREAS, THE DEKALB COUNTY BOARD OF COMMISSIONERS desires to make safety improvements to existing Dekalb-Peachtree Airport by soliciting and receiving bids from Hi-Lite Airfield Services, LLC for Airfield Crack Seal & Remarking at the DeKalb Peachtree (PDK) Airport, and Michael Baker International to provide Resident Inspection and Construction Administrative Services for the project, and;

WHEREAS, THE DEKALB COUNTY BOARD OF COMMISSIONERS will receive a contract from the Georgia Department of Transportation (GDOT) contract AP026-9000-58(089) DeKalb County to provide reimbursement for the costs associated with the above noted Services up to a maximum amount not to exceed the total estimated cost of \$936,638.45 of which up to \$702,478.84 will be State Funds and requiring a local match of approximately \$234,159.61 and;
