Protecting and Building Communities

- Through health & wellbeing free screenings, referrals and services
 - FREE health screenings (cholesterol, diabetes and blood pressure) navigation and referral services



FREE in-language educational workshops in Know Your Rights for patients, tenants and in school at community events and for visitors to the Mexican Consulate

About our Health & Wellbeing Program

The purpose of the Health & Wellbeing Program is to educate, mitigate, and support the Latinx and immigrant community in Georgia in their journey towards a healthy, informed and self sufficient community.

Annually, our health and wellbeing program provides direct services (in person) to approximately 18,000 people with the bulk of the numbers delivered within Dekalb County through various community fairs, our annual soccer camp, and consistent work in various international consulates. We estimate over 50,000 people are reached with public health education both digitally and in-person every year statewide.
