

Amendment No. 1 to Agreement No. 00228675.0



This Amendment No. 1 is entered into by and between **DeKalb County, Georgia** (“**County**”) and **Environmental Systems Research Institute, Inc.** (“**Esri**”).

WHEREAS, County and Esri (collectively referred to as the “Parties”) entered into an Enterprise Agreement with an effective date of November 14, 2019 (hereinafter “EA”); and

WHEREAS, the Parties desire to amend the EA to extend the term for an additional one (1) year for a cost of Five Hundred and Twenty-Eight Thousand Dollars (\$528,000.00); and update applicable language, appendices and pricing for the extension period.

NOW THEREFORE, the Parties agree that the above referenced EA is modified as follows:

1. Article 7-*Term, Termination, and Expiration*, 7.1 *Term*, b. *EA Term* is revised to add the following sentence to the end of the provision: -
The EA term is extended for the one (1) year period (“Amendment 1 EA Term”) stated in the attached Appendix B, unless terminated earlier pursuant to the EA.
2. Appendix A Products and Deployment Schedule of the EA shall remain unchanged for the Amendment 1 EA Term.
3. Delete and replace Appendix B EA Fee Schedule with the attached Appendix B EA Fee Schedule for the Amendment 1 EA Term.

Except as may be specifically modified by this Amendment No. 1, all other terms and conditions of the EA and any prior Amendment(s) or Addendum(s) constitute the entire agreement between the Parties and supersede all prior and contemporaneous agreements or representations, written or oral, concerning the subject matter of this EA.
