The services provided under the Agreement will continue to be provided in the same manner, and it is envisioned that the staff of the Company who currently provide services under the Agreement will continue to do so as employees or contractors, as the case may be, of Help at Home.

To the extent required under the Agreement as stipulated in **Section E**, the Company hereby requests your consent to the Assignment and asks that you waive any notices, rights or requirements related to the Assignment or the Transition. By signing below, you grant such consent and agree and acknowledge that the Assignment shall not constitute a breach, default or termination under the Agreement. Please confirm your consent, acknowledgment and agreement to the foregoing, including the Assignment, by signing a copy of this letter where indicated below no later than June 30<sup>th</sup>, 2025.
