Request: To rezone properties from R-100 (Residential Medium Lot-100) to R-75 (Residential Small Lot-75) to allow for the construction of a single-family, detached residential subdivision.

Property Owner(s): Joe and Liezl Martin

Acreage: 12.04

Existing Land Use: One single-family home and vacant, wooded land.

Surrounding Properties: Surrounding properties to the east, west, south, and northwest (across Rockbridge Road) are zoned R-100 and are occupied by single-family, detached homes.

Zoning History: Based on DeKalb County records, it appears that the R-100 zoning of the property has not changed since adoption of the first *Zoning Ordinance* and map in 1956.

SITE AND PROJECT ANALYSIS

Since the November 18th, 2021 Board of Commissioners and the January 6th, 2022 Planning Commission meeting the applicant has revised the application from R-60 (minimum 6,000 square foot lots) to R-75 (minimum 10,000 square foot lots) and has revised the plan to show compliance with the perimeter lot compatibility requirements of the zoning ordinance by providing lots along the western edge of the site that are at least 80% as wide as abutting subdivision lots and providing a 20-foot transitional buffer. The subject property comprises 12.04 acres on the south side of Rockbridge Road, approximately 708 feet west of Martin Road in Stone Mountain, Georgia. The site contains one single-family structure and vacant land and is heavily wooded. The site slopes moderately downward from Rockbridge Road. The site currently has an abundance of mature trees and vegetation.

The proposal is for a 27-lot, single-family, residential subdivision with 10,000 square foot lots, 24% open space, and an amenity area. The concept plan submitted by the applicant indicates the proposed subdivision will provide one access to Rockbridge Road, a two-lane Minor Arterial road with curb and gutter and no sidewalks. The revised plan eliminated the secondary access to Wexford Lane on the southwest corner of the site.

The property is located in an area of the County that is predominantly zoned R-100. Surrounding uses include single-family, detached homes in R-100 zoned subdivisions to the northwest, south, east, and west. The existing R-100 zoning would allow approximately 24 lots on the subject property, taking into account that as a general rule approximately 30% of any given property that would be devoted to roads and open space. The applicant’s R-75 plan is providing only three more lots (27) than could be developed under the existing R-100 zoning which appears to be compatible with the R-100 zoned properties in the adjacent and surrounding area.

LAND USE AND ZONING ANALYSIS

Section 27-7.3.5 of the Zoning Ordinance, “Standards and factors governing review of proposed amendments to the official zoning map” states that the following standards and factors shall govern the review of all proposed amendments to the zoning maps.

A. Whether the zoning proposal is in conformity with the policy and intent of the comprehensive plan:

The rezoning request for a single-family zoning district (R-75) and single-family, detached residential uses appears to be consistent with the following policy of the *2035 Comprehensive Plan*, which is intended to support and promote the orderly development of single-family residential areas: 1. “Protect stable neighborhoods from incompatible development that could alter established single-family residential development patterns and density” (Suburban Residential Protection Strategy, pg. 115).

B. Whether the zoning proposal will permit a use that is suitable in view of the use and development of adjacent and nearby properties:

R-75 zoning would allow approximately 36 lots on the subject property whereas R-100 zoning would allow approximately 24 lots, taking into account that as a general rule approximately 30% of the site that would be devoted to roads and open space. Alternatively, the applicant’s R-75 plan is only proposing 27 lots; three more lots than would be allowed in the existing R-100 district. Additionally, the revised plan submitted after the January 6th Planning Commission meeting shows compliance with the perimeter lot compatibility requirements of the zoning ordinance by providing lots along the western edge of the site that are at least 80% as wide as abutting subdivision lots and providing a 20-foot transitional buffer. Therefore, it appears that the zoning proposal will permit a use that is suitable with adjacent and surrounding properties.

C. Whether the property to be affected by the zoning proposal has a reasonable economic use as currently zoned:

It appears that the property may have reasonable economic use with R-100 zoning considering the multitude of R-100 residential development surrounding the subject property.

D. Whether the zoning proposal will adversely affect the existing use or usability of adjacent or nearby property:

The revised plan submitted after the January 6th Planning Commission meeting shows compliance with the perimeter lot compatibility requirements of the zoning ordinance by providing lots along the western edge of the site that are at least 80% as wide as abutting subdivision lots and providing a 20-foot transitional buffer. Therefore, it does not appear that the zoning proposal will adversely affect the existing use of adjacent and nearby properties.

E. Whether there are other existing or changing conditions affecting the use and development of the property, which give supporting grounds for either approval or disapproval of the zoning proposal:

There do not appear to be other existing or changing conditions affecting the use and development of the property which give supporting grounds for either approval or disapproval of the zoning proposal.

F. Whether the zoning proposal will adversely affect historic buildings, sites, districts, or archaeological resources:

Based on the submitted information, no historic buildings, sites, districts, or archaeological resources are located on the property or in the surrounding area.

G. Whether the zoning proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, utilities, or schools:

There has been no indication from reviewing departments and agencies that the proposal would cause excessive use of utilities. Comments received from the Board of Education indicate that impacts from this development on school capacity are expected to be minimal. The applicant will need to obtain a sewer capacity letter from the Department of Watershed Management to verify if sewer capacity is available.

H. Whether the zoning proposal adversely impacts the environment or surrounding natural resources:

The proposed development would not impact the environment to a greater degree than what is expected for single-family, residential development of a wooded property. While there are floodplains and stream buffers on the project site, those environmental impacts will be addressed and mitigated during the land development permit review stage and beyond. The *DeKalb County Code of Ordinances* requires post-construction storm water run-off to be no greater than pre-construction storm water run-off and as required by the *Georgia Storm Water Management Manual*, subject to approval by the Division of Land Development. Furthermore, water quality must meet the minimum requirements of the *Georgia Stormwater Management Manual* or DeKalb County requirements.

STAFF RECOMMENDATION: APPROVAL WITH CONDITIONS (REVISED 01/07/22)

Since the November 18th Board of Commissioners meeting and the January 6th, 2022 Planning Commission meeting the applicant has revised the application from R-60 (minimum 6,000 square foot lots) to R-75 (minimum

10,000 square foot lots) and has revised the plan to show compliance with the perimeter lot compatibility requirements of the zoning ordinance by providing lots along the western edge of the site that are at least 80% as wide as abutting subdivision lots and providing a 20-foot transitional buffer. Additionally, the applicant's R-75 plan is providing only three more lots (27) than could be developed under the existing R-100 zoning which appears to be compatible with the R-100 zoned properties in the adjacent and surrounding area. The request for a single-family zoning district (R-75) and single-family detached residential uses appears to be consistent with the policy of the *2035 Comprehensive Plan*, to protect stable neighborhoods from incompatible development that could alter established single-family residential development patterns and density (Suburban Residential Protection Strategy, pg. 115).

Therefore, it appears that the zoning proposal will permit a use that is compatible with adjacent and surrounding properties and is consistent with the policies and strategies of the Comprehensive Plan. It is the recommendation of the Planning & Sustainability Department that the request be "Approved" subject to the following recommended conditions.

1. The subject property shall be developed for a maximum of 27 single-family, detached fee-simple lots. Locations of proposed lots shall be generally consistent with the locations shown on the plan dated "06/15/21" and titled "Rockbridge Road". Lot # 11 shall have a minimum rear lot width of 86.4 feet, Lot # 12 shall have a minimum rear lot width of 28 feet, and Lot # 13 shall have a minimum rear lot width of 115 feet to comply with the perimeter lot compatibility requirements of the zoning ordinance.
2. There shall be a minimum of 20% enhanced open space on the project site.
3. Any fences or walls proposed along Rockbridge Road shall comply with the wall and fence regulations of the *Zoning Ordinance*.
4. Building materials and form shall comply with Article 5.7 of the *Zoning Ordinance*.
5. Rockbridge Road is an arterial road. Please see chapter 5 of the zoning code and chapter 14-190 of the *Land Development Code* for required infrastructure requirements. Location of proposed access on to Rockbridge Road and any required right-of-way dedication and transportation improvements along Rockbridge Road shall be installed prior to the issuance of any building permits subject to review and approval by the Transportation Department.
6. Post-construction storm water run-off shall be no greater than pre-construction storm water run-off in accordance with the *DeKalb County Code of Ordinances* and as required by the Georgia Storm Water Management Manual, subject to approval by the Land Development Division of the Planning Department. Furthermore, water quality shall meet the minimum requirements of the Georgia Storm water Management Manual or DeKalb County requirements.
7. The development shall have a mandatory property owners association, in accordance with Article 5.7.6.c.11 of the *Zoning Ordinance*. The applicant must provide evidence of a legal mechanism under which all land to be held in common and used for greenspace purposes within the development and all landscaping and street trees along Rockbridge Road and the proposed internal residential street (outside of the right-of-way) shall be protected in perpetuity. Existing trees located within designated open space areas that are not proposed for trails, buildings, structures, or parking lots or those likely to be impacted by necessary grading shall be preserved.

NEXT STEPS

Following an approval of this zoning action, one or several of the following may be required:

- ✔ • **Land Disturbance Permit** *(Required for of new building construction on non-residential properties, or land disturbance/improvement such as storm water detention, paving, digging, or landscaping.)*
- ✔ • **Building Permit** *(New construction or renovation of a building (interior or exterior) may require full plan submittal or other documentation. Zoning, site development, watershed and health department standards will be checked for compliance.)*
- ✔ • **Certificate of Occupancy** *(Required prior to occupation of a commercial or residential space and for use of property for a business. Floor plans may be required for certain types of occupants.)*
- ✔ • **Plat Approval** *(Required if any parcel is being subdivided, re-parceled, or combined. Issued “administratively”; no public hearing required.)*
- ✔ • **Sketch Plat Approval** *(Required for the subdivision of property into three lots or more. Requires a public hearing by the Planning Commission.)*
- **Overlay Review** *(Required review of development and building plans for all new construction or exterior modification of building(s) located within a designated overlay district.)*
- **Historic Preservation** *(A Certificate of Appropriateness is required for any proposed changes to building exteriors or improvements to land when located within the Druid Hills or the Soapstone Geological Historic Districts. Historic Preservation Committee public hearing may be required.)*
- **Variance** *(Required to seek relief from any development standards of the Zoning Ordinance. A public hearing and action by the Board of Appeals are required for most variances.)*
- **Minor Modification** *(Required if there are any proposed minor changes to zoning conditions that were approved by the Board of Commissioners. The review is administrative if the changes are determined to be minor as described by Zoning Code.)*
- **Major Modification** *(Required submittal of a complete zoning application for a public hearing if there are any proposed major changes to zoning conditions that were approved by the Board of Commissioner for a prior rezoning.)*
- **Business License** *(Required for any business or non-residential enterprise operating in Unincorporated DeKalb County, including in-home occupations).*
- **Alcohol License** *(Required permit to sell alcohol for consumption on-site or packaged for off-site consumption. Signed and sealed distance survey is required. Background checks will be performed.)*

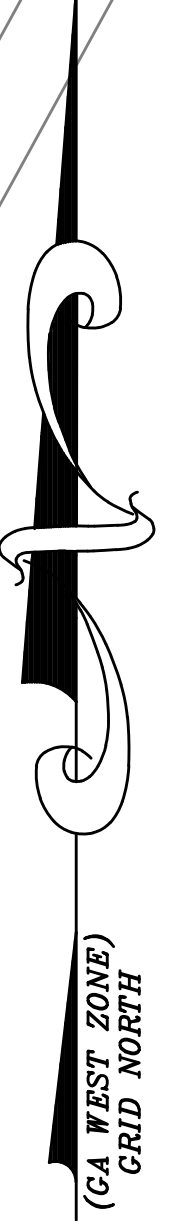
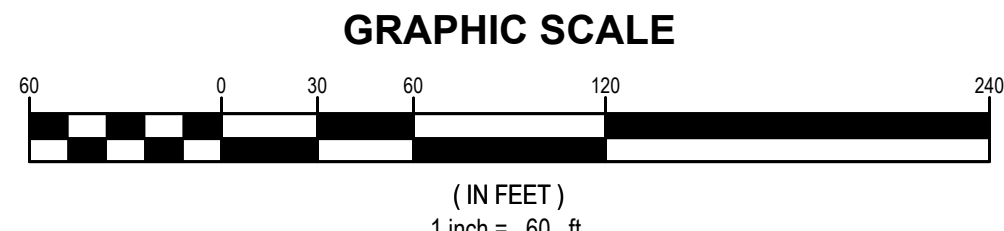

N2. Please see chapter 5 of the zoning code and chapter 14-190 of the land development code for infrastructure requirements. Linecrest Rd is classified as a collector road. Infrastructure Requirements: 35 foot right of way dedication from centerline or such that all public infrastructure is within public right of way, whichever greater, 6 foot sidewalk, 4 foot bike lane (or 10 foot multiuse path in lieu of required bike lanes and 6 foot sidewalk), 10 foot landscape strip and street lights. Verify that the access point meets intersection and stopping sight distance based on AASHTO design guidelines when submitting for permitting. Interior roads require a 27.5 foot right of way dedication from the centerline or such that all public infrastructure is on county right of way. Requires a 6 foot landscape strip, 6 foot sidewalk and street lights. Code Section 14-200 (e): 79 lots require two access points. This will require a variance to the Land Development Code prior to land development permit approval from the Transportation Division at time of permitting.

N8. Please see chapter 5 of the zoning code and chapter 14-190 of the land development code for infrastructure requirements. Rockbridge Rd is classified as a minor arterial. Infrastructure Requirements: 40 foot right of way dedication from centerline or such that all public infrastructure is within public right of way, whichever greater, 6 foot sidewalk, 4 foot bike lane (or 10 foot multiuse path in lieu of required bike lanes and 6 foot sidewalk), 10 foot landscape strip and street lights. Verify that the access point meets intersection and stopping sight distance based on AASHTO design guidelines when submitting for permitting. Interior roads require a 27.5 foot right of way dedication from the centerline or such that all public infrastructure is on county right of way. Requires a 6 foot landscape strip, 6 foot sidewalk and street lights. Please note that the top section appears to have more lots per access than the code allows (Code Section 14-200 (e)- more than 75 units requires 2 access points). If access is allowed on Pepperwood- then Pepperwood to Hickory Hills Trail and Hickory Hills Drive to Rockbridge should be resurfaced by the developer and sidewalks added to connect to the new sidewalks in the proposed neighborhood to offset impacts. I would prefer to see the sidewalks added all the way to Rockbridge via Hickory Hills Trail and Hickory Hills Drive to reduce impacts to the existing property owners, if the existing property owners so desire sidewalks, but, at a minimum, the one lot sidewalk gap on Pepperwood should be eliminated.

DEVELOPMENT ANALYSIS:

- **Storm Water Management**

Compliance with the Georgia Stormwater Management Manual, DeKalb County Code of Ordinances 14-40 for Stormwater Management and 14-42 for Storm Water Quality Control, to include Runoff Reduction Volume where applicable is required as a condition of land development permit approval. Use Volume Three of the G.S.M.M. for best maintenance practices. Use the NOAA Atlas 14 Point Precipitation Data set specific to the site. Recommend Low Impact Development features/ Green Infrastructure be included in the proposed site design to protect as much as practicable the statewaters and special flood hazard areas.

- **Flood Hazard Area/Wetlands**

The presence of FEMA Flood Hazard Area **was not** indicated in the County G.I.S. mapping records for the site; and should be noted in the plans at the time of any land development permit application. Encroachment of flood hazard areas require compliance with Article IV of Chapter 14 and FEMA floodplain regulations.

- **Landscaping/Tree Preservation**

Landscaping and tree preservation plans for any building, or parking lot must comply with DeKalb County Code of Ordinances 14-39 as well as Chapter 27 Article 5 and are subject to approval from the County Arborist.

- **Tributary Buffer**

State water buffer **was** reflected in the G.I.S. records for the site. Typical state waters buffer have a 75' undisturbed stream buffer and land development within the undisturbed creek buffer is prohibited without a variance per DeKalb County Code of Ordinances 14-44.1.

General Comments:

DeKalb County Health Regulations prohibit use of on-site sewage disposal systems for

- multiple dwellings
- food service establishments
- hotels and motels
- commercial laundries
- funeral homes
- schools
- nursing care facilities
- personal care homes with more than six (6) clients
- child or adult day care facilities with more than six (6) clients
- residential facilities containing food service establishments

If proposal will use on-site sewage disposal, please contact the Land Use Section (404) 508-7900.

Any proposal, which will alter wastewater flow to an on-site sewage disposal system, must be reviewed by this office prior to construction.

This office must approve any proposed food service operation or swimming pool prior to starting construction.

Public health recommends the inclusion of sidewalks to continue a preexisting sidewalk network or begin a new sidewalk network. Sidewalks can provide safe and convenient pedestrian access to a community-oriented facility and access to adjacent facilities and neighborhoods.

For a public transportation route, there shall be a 5ft. sidewalk with a buffer between the sidewalk and the road. There shall be enough space next to sidewalk for bus shelter's concrete pad installation.

Since DeKalb County is classified as a Zone 1 radon county, this office recommends the use of radon resistant construction.

I. STATEMENT OF INTENT

The Applicant, Builders Professional Group, LLC, is seeking to rezone the property located at 5277 Rockbridge Road, being tax parcel no. 18 038 04 003 (the "Subject Property") from R-100 to R-60. The Applicant is seeking this rezoning to R-60 to allow for a 26-unit single family-detached subdivision. The proposed subdivision is 2.3 units/acre and would be very appropriate for the Subject Property. The proposed subdivision also includes 25% (2.89 acres) open space and an amenity area. The proposed R-60 zoning and proposed single family-detached subdivision are consistent with the suburban (SUB) future land use designation and would be appropriate for the area.

This document is submitted both as a Statement of Intent and Impact Analysis with regard to this Application, a preservation of the Applicant's constitutional rights, and the Impact Analysis. A surveyed plat and conceptual site plan of the Subject Property controlled by the Applicant has been filed contemporaneously with the Application, along with other required materials.

II. IMPACT ANALYSIS

- (a) *The existing land uses and zoning classification of nearby property;*

The Subject Property is located on Rockbridge Road and is zoned R-100, with a land use designation of SUB. Other properties in the area are zoned R-100 with a future land use designation of SUB.

- (b) *The effect on adjacent properties;*

The proposed 26-unit subdivision is suitable for the area and will not adversely affect adjacent properties. The proposed project will be an asset to the greater community adding more housing options to the area.

- (c) *Whether the subject property has a reasonable economic use as currently zoned;*

The Subject Property has minimal economic use as currently zoned. Due to building costs and current market trends, the Subject Property would be better suited with smaller lots than allowed with its current zoning classification.

- (d) *Whether the proposed zoning will be a use that is suitable in view of the use and development of adjacent and nearby property;*

The proposed R-60 zoning and associated proposed development are suitable in view of the use and development adjacent and nearby property. The surrounding properties are primarily residential, similar to the proposed subdivision. Future residents of the proposed subdivision would also have the opportunity to support local businesses and enjoy the nearby Wade Walker Park.

- (e) *Whether the proposed zoning will adversely affect the existing use or usability of adjacent or nearby property;*

The proposed use will not adversely affect the existing use or usability of adjacent or nearby property. The proposed community will add 26 homes on the Subject Property, which would be an asset, rather than an adversity, for the greater neighborhood.

- (f) *Whether the zoning proposal is in conformity with the policies and intent of the land use plan;*

The zoning proposal is in conformity with the policies and intent of the land use plan. The future land use designation of the Subject Property is SUB, and the proposed R-60 zoning classification is in line with that.

- (g) *Whether the zoning proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, utilities, or schools; and*

The proposed use, a 26-unit single family-detached community, will not cause an excessive or burdensome use of existing streets, transportation facilities, utilities, or schools

- (h) *Whether there are other existing or changing conditions affecting the use and development of the property which give supporting grounds for either approval or disapproval of the zoning proposal.*

To the Applicant's knowledge, there are no other existing or changing conditions affecting the use and development of the property which give supporting grounds for either approval or disapproval of the proposed rezoning to R-60.

III. CONCLUSION

For the foregoing reasons, the Applicant respectfully requests that the Rezoning Application at issue be approved. The Applicant also invites and welcomes any comments from Staff or other officials of DeKalb County so that such recommendations or input might be incorporated as conditions of approval of this Application. Please note that the Applicant's Notice of Constitutional Allegations and Preservation of Constitutional Rights has been submitted with this Application and are attached hereto and by this reference incorporated herein.

NOTICE OF CONSTITUTIONAL ALLEGATIONS AND PRESERVATION OF CONSTITUTIONAL RIGHTS

The portions of the DeKalb County Zoning Ordinance, facially and as applied to the Subject Property, which restrict or classify or may restrict or classify the Subject Property so as to prohibit its development as proposed by the Applicant are or would be unconstitutional in that they would destroy the Applicant's property rights without first paying fair, adequate and just compensation for such rights, in violation of the Fifth Amendment and Fourteenth Amendment of the Constitution of the United States and Article I, Section I, Paragraph I of the Constitution of the State of Georgia of 1983, Article I, Section III, Paragraph I of the Constitution of the State of Georgia of 1983, and would be in violation of the Commerce Clause, Article I, Section 8, Clause 3 of the Constitution of the United States.

The application of the DeKalb County Zoning Ordinance to the Subject Property which restricts its use to any classification other than that proposed by the Applicant is unconstitutional, illegal, null and void, constituting a taking of Applicant's Property in violation of the Just Compensation Clause of the Fifth Amendment to the Constitution of the United States, Article I, Section I, Paragraph I, and Article I, Section III, Paragraph I of the Constitution of the State of Georgia of 1983, and the Equal Protection and Due Process Clauses of the Fourteenth Amendment to the Constitution of the United States denying the Applicant an economically viable use of its land while not substantially advancing legitimate state interests.

A denial of this Application would constitute an arbitrary irrational abuse of discretion and unreasonable use of the zoning power because they bear no substantial relationship to the public health, safety, morality or general welfare of the public and substantially harm the Applicant in violation of the due process and equal protection rights guaranteed by the Fifth Amendment and Fourteenth Amendment of the Constitution of the United States, and Article I, Section I, Paragraph I and Article I, Section III, Paragraph 1 of the Constitution of the State of Georgia.

A refusal by the DeKalb County Board of Commissioners to grant the Special Land Use Permit as requested by the Applicant would be unconstitutional and discriminate in an arbitrary, capricious and unreasonable manner between the Applicant and owners of similarly situated property in violation of Article I, Section I, Paragraph II of the Constitution of the State of Georgia of 1983 and the Equal Protection Clause of the Fourteenth Amendment to the Constitution of the United States. Any granting of the Special Land Use Permit subject to conditions which are different from the conditions requested by the Applicant, to the extent such different conditions would have the effect of further restricting Applicant's utilization of the property, would also constitute an arbitrary, capricious and discriminatory act in zoning the Subject Property to an unconstitutional classification and would likewise violate each of the provisions of the State and Federal Constitutions set forth hereinabove.

A refusal to grant the Special Land Use Permit in question would be unjustified from a fact-based standpoint and instead would result only from constituent opposition, which would be an unlawful delegation of authority in violation of Article IX, Section II, Paragraph IV of the Georgia Constitution.

A refusal to approve the Special Land Use Permit in question would be invalid inasmuch as it would be denied pursuant to an ordinance which is not in compliance with the Zoning

Procedures Law, O.C.G.A Section 36-66/1 et seq., due to the manner in which the Ordinance as a whole and its map(s) have been adopted.

The existing zoning classification on the Subject Property is unconstitutional as it applies to the Subject Property. This notice is being given to comply with the provisions of O.C.G.A. Section 36-11-1 to afford the County an opportunity to revise the Property to a constitutional classification. If action is not taken by the County to rectify this unconstitutional zoning classification within a reasonable time, the Applicant is hereby placing the County on notice that it may elect to file a claim in the Superior Court of DeKalb County demanding just and adequate compensation under Georgia law for the taking of the Subject Property, diminution of value of the Subject Property, attorney's fees and other damages arising out of the unlawful deprivation of the Applicant's property rights.



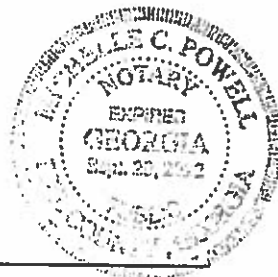

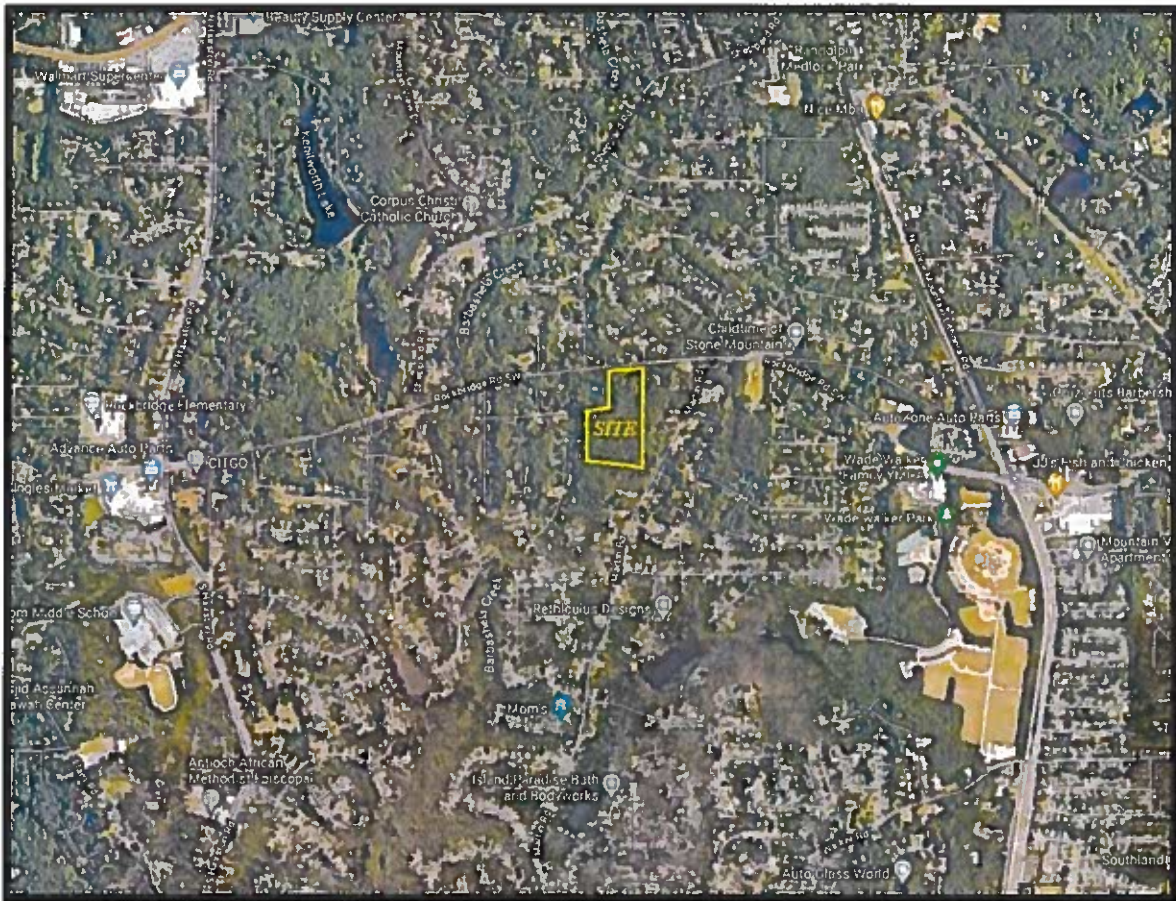


Figure 1 – Site Location Map

The trip generation was calculated for a proposed single family residential subdivision in DeKalb County, Georgia. The site is located along the south side of Rockbridge Road, as shown in Figure 1.

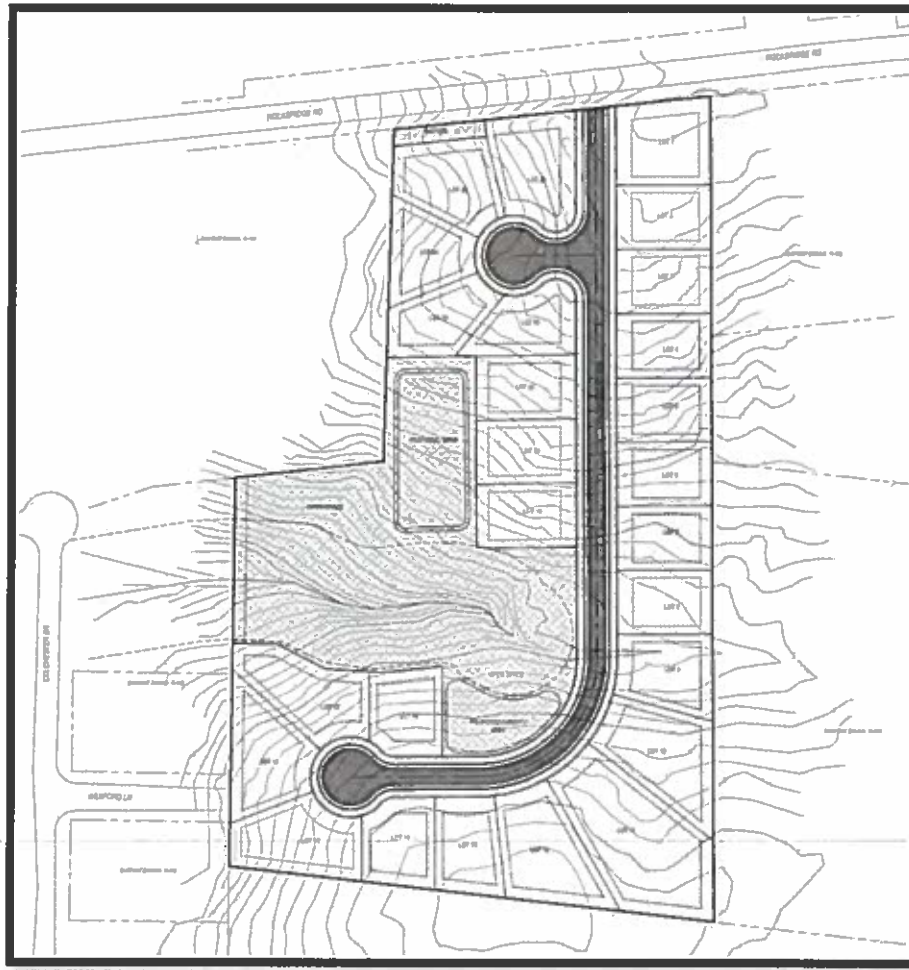


Figure 2 – Site Plan

The site will be developed with 26 single family homes which will be served by one full-movement access on Rockbridge Road. The site plan is presented in Figure 2.

The volume of traffic that will be generated by the proposed subdivision was calculated using the equations in the Institute of Transportation Engineers (ITE) *Trip Generation Manual, 10th Edition – with Supplement* (the current edition). ITE Land Use 210 – Single-Family Detached Housing was chosen as representative of the project. The trip generation is summarized in Table 1.

The proposed subdivision will generate 23 a.m. peak hour trips, 28 p.m. peak hour trips, and 302 weekday trips.
