

Memorandum of Understanding

Securing the Cities Grant

This Memorandum of Understanding, entered into between the City of Atlanta, Mayor's Office of Emergency Preparedness (MOEP), 68 Mitchell Street, Atlanta, Ga. 30303, and the Securing the Cities (STC) Regional Partners, to include DeKalb County, Georgia, a political subdivision of the State of Georgia (for and on behalf of the DeKalb County Police and Fire Department), who is identified on the attached signature page for the acquisition and distribution of goods and services pursuant to the Securing the Cities Program. This agreement is a statement of understanding and should not be construed as a legally binding contract between the City of Atlanta, Mayor's Office of Emergency Preparedness, and the Securing the Cities Regional Partners.

Whereas, City of Atlanta, Mayor's Office of Emergency Preparedness and the Securing the Cities Regional Partners intend to work in concert with other regional agencies to develop and implement systems for coordinated and integrated detection, interdiction, and notification of illicit materials outside regulatory control that may be used in a terrorist attack or as a weapon of mass destruction within the region; and

Whereas, the City of Atlanta, Mayors Office of Emergency Preparedness and the STC Regional Partners recognize the critical need for mutual information sharing, operational integration, and regional cooperation to implement the Securing the Cities Program (sometimes referred to as "STC Program") effectively; and

Whereas, the City of Atlanta, Mayors Office of Emergency Preparedness has received or expects to receive monetary and non-monetary assistance (Federal Grant Funding) from the federal government including substantial involvement in the program development; and

Whereas, the Mayor or her designee has been authorized to apply for and accept the FY2019 U.S. Department of Homeland Security's (DHS) Countering Weapons of Mass Destruction grant pursuant to Ordinances 20-O-1295 and 20-O-1571; and

Whereas, such Federal Grant Funding is to be used exclusively to support the Securing the Cities Program implementation; and

Whereas, The City of Atlanta Mayors Office of Emergency Preparedness and the STC Regional Partners agree to collaborate in the design and operations of STC program.

Now Therefore, the parties agree as follows:

1. The City of Atlanta Mayors Office of Emergency Preparedness and the STC Regional Partners agree to work collaboratively in the development and enhancements to the regions capability to detect and prevent a terrorist attack or other high consequence events utilizing nuclear or other radiological material that pose a risk to homeland security.
2. The City of Atlanta Mayors Office of Emergency Preparedness agrees to collaborate and participate in the performance of activities with the Department of Homeland Security (DHS). Co-lead committee meetings with elected chairs and will assist in the identification and validation of regional requirements for training, equipment, and reporting/information exchange.
3. The City of Atlanta Mayors Office of Emergency Preparedness agrees to provide operational information and complete all reporting mechanisms pursuant to documenting the implementation and operation of provided equipment, goods, and services.
4. The City of Atlanta Mayors Office of Emergency Preparedness agrees to work with the regional partners to ensure approved and authorized equipment that is designed to enhance the parties' capabilities is procured, inventoried, and distributed to achieve the regional goals.
5. The Atlanta Region STC Program Office will collaborate and participate in the performance of activities with DHS and our regional partnering agencies to develop and manage an equipment sustainment plan covering maintenance, calibration, and recapitalization.
6. The STC Regional Partners will provide and maintain a primary liaison to the City of Atlanta Mayor's Office of Emergency Preparedness STC Program Manager, including name, work address, e-mail address and telephone number. In addition to a primary liaison, each STC regional partner will ensure the functional area committees are staffed with effective leadership in each committee.
7. The STC Regional Partners agree to facilitate/coordinate equipment distribution upon initial acquisition and maintain records of personnel assigned equipment. Report any lost, stolen, damaged or defective equipment to the STC Program Manager.

8. The STC Regional Partners agree to provide timely notification and share security information with each other related to deployment, operation of equipment, goods, and service pursuant to this agreement.
9. The STC Regional Partners will use any equipment or goods received or purchased through the STC Program only for the purposes for which they are intended and shall keep them in good working order. The parties agree to cooperate in the maintenance of the equipment or goods pursuant to this agreement.
10. The STC regional partners agree to reasonably participate in all regional training exercises providing sufficient personnel and equipment as determine necessary by the STC committee process. The STC Regional Partners further agree to ensure department personnel attend the initial R/D detection training.
11. The STC regional partners agree to comply with the City of Atlanta Mayor's Office of Emergency Preparedness STC guidelines regarding documentation and submission requirements for reimbursement for training and exercise participation in furtherance of the STC Program.
12. Reimbursement funds will only be provided if the funds are available in the STC budget and the City of Atlanta will not be held responsible if there is no STC funding available.
13. Any amendments to this Memorandum of Understanding must be in writing and signed by authorized representatives of the parties.
14. This Memorandum of Understanding will remain in effect from the date each STC Regional Partner's authorized representative signs the Agreement until September 30, 2029, unless terminated by either party within 30 days of written notification. In the event that an STC Regional Partner request to opt out of this agreement, any equipment received or purchase through the STC Program shall be returned to City of Atlanta Mayor's Office of Emergency Preparedness within 60 days for redistribution among the remaining STC regional partners.
15. Our region STC Program Award is expected to expire on September 30, 2029, at which time this MOU will expire, and all goods and equipment procured from the STC Program will permanently become the property of the STC Regional Partner.
