Metz Culinary Management, Inc. was deemed non-responsive for failure to do the following: Submit a Private Home Care Provider License for Georgia, meet the LSBE requirements, and submit the Cost Proposal Form. J&J Optimal Choice, LLC dba Home Instead Senior Care was deemed non-responsive for failure to meet the LSBE requirements. The score below has been rounded to the nearest whole number.
