***Note – The user department and the Department of Purchasing and Contracting must mutually agree before determining if a bidder is non-responsible.*

Justification:

DWM is recommending awarding EnvrioWaste Services Group, Inc. \$5,309,900, CamKen Consulting, Inc. \$5,703,700, and Compliance EnviroSystems, LLC \$6,668,570 to perform critical infrastructure assessment to provide data for rehabilitation recommendation of the DeKalb County sanitary sewer collection system. To maximize cost savings and productivity, DWM will look into each vendor to allocate which pay line items unit cost best represent DWM's needs. Concurrently, comprehensive rehabilitation of sewer mains, manholes and lateral connections in specific areas identified as having high Inflow/Infiltration is ongoing. This comprehensive rehabilitation effort represents a significant expansion of the previous plan that addressed only assets with high priority defects identified from sewer assessments(PASARP). The goal of the expanded rehabilitation efforts is to address high priority defects to significantly reduce Inflow/Infiltration in large areas of the collection system(OSARP). As areas are completed, the effectiveness for Inflow/Infiltration reduction will be analyzed to determine whether further capacity improvements are needed. This work directly impacts Consent Decree projects, in that it will provide an opportunity to reduce Inflow/Infiltration within the system providing more long term benefits to the environment and the public as opposed to only constructing larger assets to convey the excess wastewater. The rehab recommendations obtained through assessment will be used to improve the County's infrastructure and reduce sanitary sewer overflows throughout the system.
