=> Once a week service, 34 weeks @ \$11,081.75/wk. (January – May & October - December),

\$376,779.50

=> Twice a week service, 18 weeks @ \$21,580.25/wk. (June – September),

\$388,444.50

#### **Russell (Group II, 29 Locations)**

=> Once a week service, 34 weeks @ \$18,026.23/wk. (January – May & October - December),

#### **Additional Notes:**

Beautification recommend award to American Eagle, Group I and to Russell, Group II, the two most responsive and responsible bidders.

Reference checks were conducted and reviewed on the other bidders (4SYT, KSK, Ed Castro & Williams Strategic). All four bidders did not meet the critical experience required:

- A. Contractor(s) shall have previous work experience in completing this scope of work. Custodial services completed in buildings or facilities is not equivalent to this scope of work and shall not be counted as previous work experience.
- B. Contractor(s) shall have a minimum of three (3) years of experience on road-side litter removal service on high traffic corridors with the cities or government. Contractor(s) not meeting three (3) years minimum requirement will not be considered for this contract.
- A. Contractor(s) shall have experience on litter removal service at MARTA bus stops/shelters.
- C. Contractor(s) shall provide proof of above required experience.
