Due to the custom installation and tight integration of the newly installed AV room management system, it would be difficult for another provider to fully support the environment with all the current complex customizations. BIS Digital engineered, installed, configured, and supports all DeKalb County Government (DCG) Courtrooms, DCG Conference Rooms located at Sam's Street, and the newly remodeled Maloof Auditorium which will include an upgraded AV system and control room. Failure to approve will result in extended downtime, lost productivity, and loss of room functionality resulting from inoperable equipment. Downtime may extend from hours, days, or even weeks while we search for replacements and attempt to re-configure and replace equipment.

Given these factors, maintaining the current platform is not only more cost-efficient but also essential to preserving the integrity of the courtrooms' AV framework. I recommend this be awarded as a Single Source.
