# **Voucher Distribution Locations and Times**

In order for a family to receive a Youth Summer Voucher for their child, they must come to the distribution location with following documents:

- Driver's license or other proof of DeKalb County residency
- > Original income eligibility documentation with (2) photocopies of that same documentation.
  - Income verification can be a copy of a Medicaid card, Peach Care Insurance Card, other form of government assisted insurance, or a 2016 signed income tax return.
  - Child's name must be listed as a dependent on any 2016 tax return being used as income verification and the family income cannot exceed the HUD income limits.
- Vouchers will be distributed on a first come first serve basis.

# 2017 YOUTH SUMMER VOUCHER INCOME LIMITS BY FAMILY SIZE

2016 HUD INCOME LIMITS to be used in the event 2017 HUD INCOME LIMITS are not released prior to May 1<sup>st</sup>, 2017. HUD INCOME LIMIT updates will be sent via email.

(HUD INCOME LIMITS RELEASED AS OF 03/28/16)

Family Size	Maximum Income Limit Allowed
2 Persons	\$43,200
3 Persons	\$48,600
4 Persons	\$54,000
5 Persons	\$58,350
6 Persons	\$62,650
7 Persons	\$67,000
8 Persons	\$71,300

Family incomes exceeding the limits above are <u>NOT</u> eligible to receive vouchers. A copy of required income verification (copy of Medicaid Card, Peach Care Insurance Card, or 2016 signed income tax return) must be stapled to the original voucher. Vouchers can only be accepted by DeKalb County residents and can only be redeemed at pre-approved programs within DeKalb County.

EBT, Food Stamps, DFACS Case Numbers or the Free/Reduced Lunch Program are **NOT** considered eligible forms of income verification and shall **NOT** be accepted.
