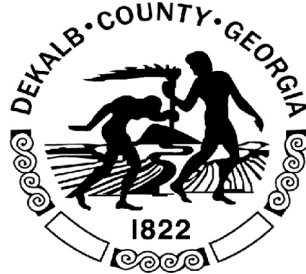

1. Dr. Ed Williams, P.O. Box 361626 Decatur, GA 30036 - Good Morning Commissioners. I would encourage the commission to reconsider its intention to take action on agenda items 2021-2521, 2021-2522, and 2021-2523. Public officials have an obligation to be open and transparent and not violate public trust. On April 20, 2021, the commission met where it added and discussed the land at 2109 Bouldercrest S.E. that DeKalb County in which it received in an exchange with Blackhall Studios. County officials are now taking steps to designate the property it negotiated in a trade as a "pocket of blight" On April 20, 2021, The BOC during the Committee of the Whole meeting accepted several items as walk-on items. The minutes of April 20, 2021, do not reflect which commissioner added the item nor does it reflect any vote to add the items to the agenda. The final minutes of April 20, 2021, was never approved by the BOC. This action was a violation of the BOC standing procedural rules and the Open Meetings Act as these items were known well in advance of the April 20, 2021 meeting but were not placed on the published Committee of the Whole meeting agenda. This is a violation of the Georgia Open Meetings Act. There are penalties for violation of the public trust and Open Meetings Act, In addition, Georgia code Chapter 36-61 provides for commissioners who because of "neglect of duty, or misconduct in office, a commissioner may be removed, but only after a hearing. He shall be given a copy of the charges at least ten days prior to such hearing and shall have an opportunity to be heard in person or by counsel" Georgia statute 36-61-5 states that no "county shall exercise any of the powers conferred upon municipalities and counties by this chapter until after its local governing body has adopted a resolution finding that: (1) One or more pockets of blight exist in such municipality or county; and (2) The rehabilitation, conservation, or redevelopment, or a combination thereof, of such area or areas is necessary in the interest of the public health, safety, morals, or welfare of the residents of the municipality or county." Commissionaires should table items 2021-25221, 2021-2522, and 2021-2523 and any other items that have not been through the commission normal procedures. These items present a clear and present violation of the Opening Meetings Act by the commission as it took action on walk-on items that were expected to be voted on that were not placed on the meeting agenda to keep the public in the dark. The commission cannot intentionally and willfully omit an item from its agenda and then vote on it claiming that it was necessary to add to the agenda during the same meeting where it failed to include all expected items it knew about well in advance of the meeting and the creation of the meeting agenda. DeKalb County officials were not forthcoming with its intentions and tried to hide what they were doing from the public In particular the commission in its effort to designate the land at 2109 Bouldercrest S.E. that DeKalb County received in an exchange with Blackhall Studios as a "pocket of blight" cannot use taxpayer money in violation of the law in which it originally appropriated the money. Trading an established park for a "pocket of blight" appears on its face a failure of the county to be good Stewards of taxpayers' money and an abdication of the county officials' fiduciary duties. Here again, the county attorneys are failing to provide proper counsel and are enabling county officials to violate the law. A legal notice was posted in the legal section of The Champion on April 8th. A full 12 days before the April 20th COW meeting but was not on the printed agenda. Instead, all three of these changes were walked on the agenda. What is also egregious is that the minutes do reflect how the items were added to the agenda and who did it. As this commission is aware the Supreme Court has ruled on this issue that "all expected items" means that items that are known before a meeting agenda is published should appear on the agenda and that adding necessary items does not relieve the commission from its legal obligations to do so. In fact, the Supreme in Williams v. DeKalb County in 2020 described any action to contrary a criminal act. In this case, like in Williams v. DeKalb County, the commission had published in the legal organ its instance to act. I ask the commission not to commit an ethics violation, or an Open Meetings Act violation, or spend taxpayer money in violation of the law and its standing procedures. I recommend you tabled these items and ask the county

attorneys to review the facts and laws related to this matter. A public official authority is limited by law.

3. Stephen Binney, 1083 Seville Dr. Clarkston, GA 30002 - Good Morning Commissioners, Ms. Cochran-Johnson, I would like to congratulate you on the start of your EMBARC program. It is a step in the right direction and I hope it lives up to it's potential. Well done. So we traded perfectly good park land for over 50 acres of a "pocket of blight". Wasn't Blackhall Studios supposed to clean up that "pocket of blight". What happened? Mr. Thurmond and Mr Rader, I think it is a little early to be all supercalifragilisticexpialidocious on our water billing. When will the first cutoffs actually be made? Can CARES funds be used to help those who will need it? What happens to the year and a half of bills that were never sent out? Is that going to be water under the bridge or will we be billing these people? I have been asking that question for over 5 years and have yet to receive an answer. I would not sunset the Water Billing Board until after our new billing system is in operation, now scheduled for September of 2022. The potential for miscommunication with users and problems with bills will be very great during this time. I have to disagree with you Ms Davis-Johnson. Solutions do not flow from the top down. As a civil rights activist you should know that solutions flow from the people up. Rosa Parks was not a CEO. The top did not even acknowledge there was a problem with water billing until over 400 people showed up at a meeting to demand answers and changes, along with newspaper articles and local TV news stories. Dekalb County has a hard time acknowledging that a problem exists until it is too late and it takes 6 to 20 years to fix the problem while its citizens suffer. Our Water billing, Sewage, Ambulance service, Procurement, and especially our LSBE program are all examples of this type of behavior. Dekalb County works very hard, in fact too hard, to maintain its status quo. Lack of openness with its residents. Pay raises walked on at the last moment. A charter review committee that has only met once in more that 3 years and is currently inactive. Transparency by government shows a trust in its citizens. Dekalb County does not seem to trust its citizens. Being proactive, looking for problems, instead of being reactive and waiting for the problems to find you would indicate that you care about your constituents. Dekalb County does not seem to care as much about its constituents as it cares about itself. And finally, under item #2395 we are replacing 5 Nord Helical - Bevel Gearmotors for 129 thousand dollars. The original Gearmotors were installed in 2019. 26 thousand dollars a piece for less than 2 years of function? This does not come across as a good deal. Were the products defective or was proper maintenance an issue? Thank you for your time and consideration




