AN ORDINANCE

AN ORDINANCE TO AMEND THE CODE OF DEKALB COUNTY, GEORGIA, AS REVISED 1988, CHAPTER 17, ARTICLE XXI, SECTION 362, PERTAINING TO PARKING RESTRICTIONS AND FOR OTHER PURPOSES.

WHEREAS, the Governing Authority of DeKalb County is tasked with the protection of the county's public health, safety, and general welfare; and

WHEREAS, O.C.G.A. § 40-6-371(a) authorizes counties to enact ordinances which regulate stopping, standing, or parking with respect to streets; and

WHEREAS, Chapter 17 of the Code of DeKalb County, as revised 1988, currently regulates motor vehicles, stopping, standing, and parking on streets in unincorporated DeKalb County; and

WHEREAS, the DeKalb County Board of Commissioners desires to protect the public's health, safety and general welfare by restricting parking on certain streets on which parking is currently authorized.

NOW, THEREFORE, be it ordained by the Governing Authority of DeKalb County, Georgia, and it is hereby ordained by the authority of same, that Chapter 17 of the Code of DeKalb County, Georgia, as Revised 1988, be amended as follows:

PART I. ENACTMENT

Section 17-362 shall be amended to add the following streets to the existing list of streets, in alphabetical order:

Sec. 17-362. - No parking generally.

Blueberry Trail, odd-numbered side, from Mount Olive Drive to the cul-de-sac, no parking, 7:00 a.m. to 10:00 a.m. and 2:00 p.m. to 5:00 p.m. on school days.

Country Squire Drive, both sides, from Delcourt Drive to Country Squire Lane, no parking, 8:00 a.m. to 10:00 a.m. and 3:00 p.m. to 5:00 p.m. on school days.

Delcourt Drive, both sides, from Atterberry Place to cul-de-sac (Druid Hills Middle School end), no parking, 8:00 a.m. to 10:00 p.m. and 3:00 p.m. to 5:00 p.m. on school days. Druid Hills Middle School Parallel Parking Zone excluded from the restrictions.

Harcourt Drive, both sides, from Mount Olive Drive to Lawrenceville Hwy, no parking, 8:00 a.m. to 10:00 a.m. and 3:00 p.m. to 5:00 p.m. on school days.

Mount Olive Drive, both sides, from Blueberry Trail to 3067/3075 Mount Olive Drive and south Druid Middle School property line, no parking, 8:00 a.m. to 10:00 p.m. and 3:00 p.m. to 5:00 p.m. on school days.

PART II. EFFECTIVE DATE

This ordinance shall become effective upon adoption by the Board of Commissioners and approval by the Chief Executive officer.

PART III. SEVERABILITY

Should any section or provision of this ordinance be declared by a court of competent jurisdiction to be invalid or unconstitutional, such decision shall not affect the validity of the ordinance as a whole, nor any part thereof, other than the part so declared to be invalid or unconstitutional. All ordinances or resolution, or parts thereof, in conflict with this ordinance are repealed.
