Thank you for applying for the Community Health Partnership Grants program with The Fulton-DeKalb Hospital Authority. Congratulations! Our grants review committee reviewed your proposal and chose to fund DeKalb County Juvenile Court for our long term grant efforts for 2018.

The total amount of the grant award is \$7,400. These funds cover the approved expenses in your budget: everything except for the fitness and nutrition facilitators. We are unable to fund memberships to a gym, we suggest you explore partnerships with the Board of Education or YMCA for those efforts. You can also resubmit for one of our other funding efforts. The review committee added the request that we would like our logo placed on shirts that are funded through this effort.

A check for one third of your grant award will be presented at our **2018 FDHA Grantee Kickoff Breakfast held on January 9th from 9:30 am to 11:30am** at our offices at 50 Hurt Plaza, Atlanta, GA 30303. Only one representative from your organization must attend the program orientation/kick off to receive your 1st distribution. This is where the program guidelines will be explained and you will have an opportunity to ask questions. You will also receive an invitation by email in which your attendance confirmation is requested.

The balance of your grant funds will be allocated following submission of a satisfactory progress report at **mid-year due June 15, 2018 by 12 noon** and at the **end of the grant period due December 1, 2018 by 12 noon** in keeping with the nature of the awarded initiative and guidelines set by the Community Health Grants Program Committee. An acceptance letter will be provided to you at the breakfast acknowledging your receipt of the initial award funds. This letter will also serve as your agreement to adhere to the reporting and use of funds guidelines. Failure to comply with specified guidelines, or if services are discontinued, you will be responsible for the immediate return of the awarded funds to The Fulton-DeKalb Hospital Authority.

Please make sure to complete the Public Benefit Affidavit, a copy of a secure and verifiable document (driver's license or passport) of person receiving the check and submit them all information by email to Ashley Yates at ayates@thefdha.org.

Trainings and FDHA related events (1 person per training, 5 or more per event) are also a component of the grant award and **attendance is mandatory**. Please mark your calendars for the following dates; with locations and times to be forwarded:
