

### Summary description of award

The purpose of the SAFER Grant Program is to provide funding directly to fire departments and volunteer firefighter interest organizations to assist in increasing the number of firefighters to help communities meet industry minimum standards and attain 24-hour staffing to provide adequate protection from fire and fire-related hazards, and to fulfill traditional missions of fire departments. After careful consideration, FEMA has determined that the recipient's project or projects submitted as part of the recipient's application and detailed in the project narrative as well as the request details section of the application — including budget information — was consistent with the SAFER Grant Program's purpose and was worthy of award.

## **Hiring of Firefighters**

### New, Additional Firefighter(s)

#### BENEFITS FUNDED

Employees of DeKalb County Fire Rescue are provided with a hybrid retirement plan that includes a defined benefit plan that has a 1% multiplier as well as a 403B account that the employer automatically contributes 6% of the employees' salary without a match required. There is also an option for additional investment into a 457 deferred compensation plan administered by Nationwide, as well as eligibility to participate in the Georgia Firefighter Pension Fund. There are several options available for individual or family coverage for major medical, dental, and vision insurance plans with an array of costs depending on the number of dependents the employee has or the level of coverage they choose. The county has workers compensation coverage and also provides an Employee Assistance Program for the employee and their family in case there are challenges at homes that the employee and/or their family need access to professional assistance to manage. There is also a countywide wellness program available to the employees free of charge and each employee in Fire Rescue receives and annual NFPA 1582 compliant physical examination. Each employee accrues annual leave, sick leave, and holiday leave through the course of their employment with DeKalb County. Recently a tuition reimbursement program has been initiated to assist members of DeKalb County Fire Rescue in pursuing continuing education at the college or university of their choice.

#### Article 1

#### Assurances, Administrative Requirements, Cost Principles, Representations, and Certifications

I. The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. The agency should notify the recipient for information on the process for requesting a waiver from these requirements. (a) When the Federal agency has determined that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. A request to waive the application of the domestic content procurement preference must be in writing. The agency will provide instructions on the format, contents, and supporting materials required for any waiver request. Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described at "Buy America" Preference in FEMA Financial Assistance Programs for Infrastructure | FEMA.gov. Definitions The definitions applicable to this term are set forth at 2 C.F.R. § 184.3, the full text of which is incorporated by reference.
