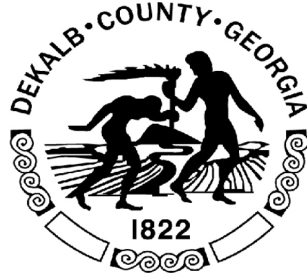

**C. COMMENTS FROM THE PUBLIC**

The purpose of public comment is to allow the public to voice county-related requests, concerns or opinions during the Commission meeting. Speakers will only have the opportunity for one public comment per meeting. Public comments may be made in person or submitted by sending an email no longer than one page to [PublicComments@dekalbcountyga.gov](mailto:PublicComments@dekalbcountyga.gov) which must be received between 9:00 a.m. and 10:00 a.m. on the day of the meeting. Only those emails received during the allotted time may be read aloud. Public comment emails received outside of the allotted time will be included in the public comment record for the next meeting after receipt of those emails. The body of your email must include your first and last name, followed by your address. By submitting an email for public comment at any time, you agree to have your name, address and email entered into the record/minutes.

Each in-person speaker must complete a speaker card and present it to the clerk before the beginning of the public comment portion of the meeting. Cards must be turned in to the clerk from the time the general meeting is convened (generally 9 A.M.) and by the beginning of public comment portion generally following presentations on the agenda. The clerk will accept cards on a first-come, first-served basis. Prior to the clerk's call for public comment, in-person speakers who are residents of DeKalb County shall be allowed to speak before residents of other counties are allowed to speak. Once the public comment portion of the meeting begins, speaker cards will no longer be accepted. Speakers will be allowed to speak for three minutes each and public comment shall not exceed 30 minutes in length. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to yield the podium. Those in-person attendees who submitted speaker cards but did not speak because of the time allotment will be allowed to speak first at the next regularly scheduled Commission meeting without regard to residence. **Public Comments: October 10, 2023- Unread Emails**

1. *James & Dawn Rayford, 1722 Limestone Terrace Lithonia, GA 30058- Good morning Board of Commissioners: Our homes have been damaged in the Sierra Highlands subdivision. We have provided you with documentation, followed the process to voice our concerns, and spoke at both Commissioners' meetings in September. We were told that you are investigating and looking into this matter. We are requesting an update on this matter and looking for a resolution. We know that bureaucracy exists in county, state, and federal levels. However, as elected officials, you are public servants who support and govern not only your constituents, but business and commerce in Dekalb County as well. Also, as elected officials, we hope that you will act on this matter and let's come up with a resolution. I have no doubt in my mind that if you were in our shoes, you would want some answers. Do for us what you would want done for yourselves. We are asking you to practice being a public servant on this matter and give us an update to come to a resolution. I have used the word resolution four times because this is our request. We look forward to hearing from you.*

2. *Ed Williams (No Address)- Dear Commissioners: I believe that the unincorporated areas of DeKalb deserve more attention and a specific person that will represent the unincorporated areas of DeKalb County. At present, the CEO and County manager have overall county duties. Unincorporated DeKalb needs commissioners and an executive management team that will focus on the interests of the residents who live in unincorporated DeKalb County. The law can be written that provides that the residents of those unincorporated areas have similar representation for those services that are provided by the county similar to those areas that have municipalities. The DeKalb SPLOST projects are being distributed unfairly. I had expressed my concern about how DeKalb County chose to divide up the SPLOST revenue that the citizens of DeKalb voted for in November 2017, and I hope the county does not repeat this in 2023. I believe that the government should treat all its citizens equitably and that the government should be transparent and its officials are held accountable. I have a huge concern with the use of the unincorporated residents' portion of the revenue to pay for what I consider to be county-wide projects where the municipalities are not sharing in the cost even though their residents use the services and facilities equally with unincorporated residents. I have reviewed the 2019 County SPLOST. I have concluded that the method and formula used are not equitable to all the residents in both unincorporated and municipalities of DeKalb County. There is a disparity in the application of the SPLOST tax funds. I hope that the County does not repeat the same inequities as was done in 2017. I hope that we can find a more equitable solution to address the county-wide projects being funded by unincorporated SPLOST revenue. The SPLOST legislation HB215*

*passed in 2015, and SB143 passed in 2017. The 2017 SPLOST was voted on by all the citizens of DeKalb, and it was divided up with the other 12 municipalities excluding the Atlanta portion of DeKalb County. I am certainly sure that you are aware that a sales tax voted on at the county level should be shared fairly throughout the district across the municipalities. I do not think the allocation of 2017 SPLOST money as it relates to the portion allocated to repair the courthouse, fire department, and other facilities that are used by the entire county should only be carried by unincorporated residents' portion of the SPLOST sales revenue. The SPLOST MOU that was signed with the other municipalities appeared to put the unincorporated residents at a disadvantage. The 2017 SPLOST of the unincorporated share of the total revenue was used to pay for those county-wide projects where these costs should have been shared by all the other municipality districts. The constitution does not authorize special districts to exempt or roll back a county or municipal ad valorem tax as a service as a premise for the special district's existence. Homestead exemptions are specifically authorized by the constitution for state, county, and municipality purposes. Special districts are limited to services and the right to tax for those services is limited under the constitution. There is no authorization to equalize municipalities' and counties' ad valorem tax in a special district outside a political subdivision of the state. The EHOST statute contorts a uniform special sales tax levy to equalize various homestead exemptions of independent separate political subdivisions disguised as a funding service. Respectfully,*

*3. Debra Phifer, 8339 Falling Rocks Way Lithonia, GA 30058- Good morning, I'm writing to advise of the damage I know that my home (and others) has experienced with the blasting that took place with the new subdivision DR Horton is building behind our subdivision. Even though there has been denial of any damages done to our homes, we honestly know there is damage. When I have experienced the blasting, there is no way the way our house shook that no damage was done, especially when they felt like earthquakes. I can visibly see the damage in my cracked walls, ceilings, uneven floors, stucco (which was just painted last year so there should be no cracks in it), etc. We have been in our home for 29 years and have kept up on maintenance just to see damage in the Fall last year after the blasting. This is just the visual damage. I shudder to think what structural damage has done that we cannot see.*

**Public Comments: October 10, 2023- Read Emails**

1. William Lentjes, 1219 N Valley Brook Rd, Decatur, GA 30033- Hello Board of Commissioners. I'm writing today to ask you about eliminating minimum parking requirements for new buildings and developments here in Dekalb. As an architect, it's something I deal with on a daily basis. Parking minimums are not only extremely expensive to the developer, taxpayer, and the county, but they are also completely unnecessary! By that, I mean that eliminating parking minimums has been shown to not affect business or revenue, as many fear. Instead of forcing developers to build large surface lots and parking decks, let them decide how much parking their project needs! Of course, the main reason this is such a cause of my concern is the serious detriment to the environment. The furthering of sprawl and the increasing of car dependency here in Dekalb county is not sustainable for us, our children, or the planet. Getting rid of minimum parking requirements has been done all over the country. The nearest example is the city of Dunwoody, where they actually changed their previous parking "minimums" into parking "maximums". This change has encouraged sustainable modes of transit -- walking, cycling, and buses. Is this something that we, Dekalb county citizens and our county commissioners, can address together? Can you adopt the Municode language used in the city of Dunwoody related to parking? This would be a great first step towards equity, justice, and change as it relates to car dependency here in unincorporated Dekalb. Thank you!

2. Lakeisha Lewis, 8459 Falling Rocks Way Lithonia GA 30058- Dear Board of Commissioners, Thank you for taking the time out to read my letter. My name is Lakeisha Lewis and my husband, and I have been homeowners in the Sierra Highlands Subdivision for 7 years. When we moved into the neighborhood we instantly fell in love with this beautiful subdivision and our forever home. This is also the only home our 7-year-old has ever known. When we originally moved here the neighboring land was filled with beautiful trees and now as we ride around our neighborhood there's nothing but flat land. It was our understanding that the neighboring land wouldn't be developed due to it being preserved as a green space because of the amount of rock that was below the land. However, over the years and during the height of the pandemic (when families were dealing with the devastating illness of covid and the loss of loved ones) Dekalb County approved for D.R. Horton to develop homes on this preserved land. Since the blasting started, our beautiful home are now left with cracks going down our walls, nail pops, peeling tape and cracks in our ceiling and concrete. Prior, to the blasting we did not have any of these issues. Our home is almost 30 years old, and any settling has already occurred. It's unfair that after putting so much time and effort and money into our homes that now here we are asking and pleading for D.R. Horton to do the right thing. This is one of the biggest

*investments that any of us will ever make in our lifetime and this isn't right. Although, the blasting company is stating that they were in the correct limits to blast this does not negate that the damages occurred to our home as well as many of our neighbors due to the blasting. This needs to be made right and we are asking for you to please assist with making it right. In addition to the blasting D.R. Horton is also now asking to change from their original development of single family detached homes to 2 and 3 story town homes. This development is not consistent with the current homes in the area. Please help us to continue to keep our community what it currently is, beautiful and thriving. It is our hope and prayer that as residents affected by the blasting of the D.R. Horton development, this will be made right. Sincerely,*

Inside my home the kitchen floor tiles showed cracks and loose grout when I sweep the kitchen floor, the elevation also has slump, Last but not least, cracks have materialize in the basement foundation. This injustice need to be corrected A.S.A.P.! I 'am frustrated, I get stressful, along with anxiety. So, please be FAIR to my family, neighbors, friends and all the other property homeowners who were here first. Sincerely,*

**D. 10:00 A.M. PUBLIC HEARING**

Citizens may speak for or against an item that is considered by law to be a zoning ordinance and each side will have ten minutes to present its case. Citizens may also speak for or against an item that is placed on the public hearing agenda but is not a zoning ordinance. In that case, each side will have five minutes to present its case.

In the event there is more than one speaker per side, speakers must divide their time in order to complete their full presentation within the ten-minute time allotment, or the five minute time allotment. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to leave the podium area. Prior to speaking, a speaker shall complete a speaker card and present it when approaching the podium. If a speaker has any documents for the commissioners, the speaker shall provide 10 copies when approaching the podium. Seven copies are for the commissioners and the remaining copies are for the planning director, the county attorney and the clerk. In all zoning ordinance and traffic calming cases, staff shall make their recommendation for action to the Commission first followed by applicants or citizens speaking in favor of the item. Applicants in zoning ordinance cases shall have the right to reserve time for rebuttal. Opponents of a zoning ordinance item shall have no right of rebuttal. For all other items placed on the public hearing agenda, applicants or citizens speaking in favor of the item shall speak first followed by opponents of the item. Once the citizens have finished speaking, staff shall make a recommendation for action to the Commission. At this point, citizens are no longer allowed to speak unless called to the podium by an individual commissioner to answer questions or provide information. Speakers should always talk directly into the microphone and begin by stating their name, address and the name of any organization they represent. Abusive, profane or derogatory language will not be permitted. Holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.
