Description of Proposed Changes: Amendment/Change Order No. 1 is being requested to provide approval from the Board of Commissioners (BOC) to increase the scope, contract term and current value of the contract to allow for the contractor Ruby Collins to perform work on the annual water and sewer projects. The initial award of \$12,752,002.78 was approved by the BOC for the contractor to perform emergency repairs to the system.

Justification of Proposed Changes: Amendment/Change Order No. 1 is needed to increase the contract amount to allow the contractor adequate funds to complete the required scope of pipe installation. Due to multiple delays in supply chain and contracting issues, DWM is in need of additional contracting capacity to perform annual water and sewer replacement work. The projects below were extracted from a list of DWM priority projects. These projects were deemed necessary due to an increasing amount of water breaks and outages during recent months. These locations contain pipe material of AC and cast-iron that have outlived the life expectancy. A number of these pipes were installed as early as 1948. Total amount of work allocated and encumbered as of May 30, 2023 is \$7,434,000.

D: Expanded amount of damage to County roadways and homeowner's property due to continued main breaks.
