CO - Change Order No. 3 to Contract No. 1274588 Card Access (Keyscan) Installation, Maintenance and Repair (Annual Contract with 2 Options to Renew): for use by the Departments of Facilities Management (FM), Watershed Management (DWM), and Police Services (PS). This contract consists of the installation, maintenance and repair of all card access points. This request seeks to increase the contract funds and term through June 30, 2025 with a price increase. This request also seeks to add Public Works - Sanitation to the contract. Awarded to: Southeastern Security Professionals, LLC. Amount Not To Exceed: \$312,000.00.

#### **PURPOSE:**

Awarded by the BOC on December 24, 2021, for an amount not to exceed \$215,000.00. On April 26, 2022, the BOC approved Change Order No. 1 to increase funding for an amount not to exceed \$585,000.00 for the inclusion of Department of Watershed Management and additional sites. On December 13, 2022, the BOC approved the 1st renewal option and added additional locations for service for an amount not to exceed \$705,000.00. On December 12, 2023, the BOC approved the 2nd renewal option for an amount not to exceed \$675,000.00. On May 14, 2024, the BOC approved Change Order No. 2 to increase funding for an amount not to exceed \$104,000.00 for inclusion of Police Services. This contract consists of the Installation, Maintenance, and Repair of all card access points. This request seeks to increase the contract funds and term through June 30, 2025 with a price increase. This request also seeks to add Public Works - Sanitation to the contract.
