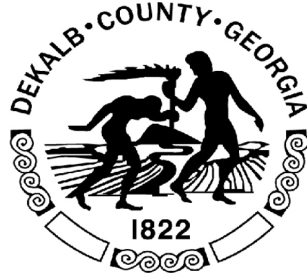

C. COMMENTS FROM THE PUBLIC

The purpose of public comment is to allow the public to voice county-related requests, concerns or opinions during the Commission meeting. Speakers will only have the opportunity for one public comment per meeting. Public comments may be made in person or submitted by sending an email no longer than one page to PublicComments@dekalbcountyga.gov which must be received between 9:00 a.m. and 10:00 a.m. on the day of the meeting. Only those emails received during the allotted time may be read aloud. Public comment emails received outside of the allotted time will be included in the public comment record for the next meeting after receipt of those emails. The body of your email must include your first and last name, followed by your address. By submitting an email for public comment at any time, you agree to have your name, address and email entered into the record/minutes. Each in-person speaker must complete a speaker card and present it to the clerk before the beginning of the public comment portion of the meeting.

Cards must be turned in to the clerk from the time the general meeting is convened (generally 9 A.M.) and by the beginning of public comment portion generally following presentations on the agenda. The clerk will accept cards on a first-come, first-served basis. Prior to the clerk's call for public comment, in-person speakers who are residents of DeKalb County shall be allowed to speak before residents of other counties are allowed to speak. Once the public comment portion of the meeting begins, speaker cards will no longer be accepted. Speakers will be allowed to speak for three minutes each and public comment shall not exceed 30 minutes in length. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to yield the podium. Those in-person attendees who submitted speaker cards but did not speak because of the time allotment will be allowed to speak first at the next regularly scheduled Commission meeting without regard to residence. If time remains in the proscribed public comment portion of said meeting, email comments will be read into the record by the clerk or designee. Any remaining email public comments received between 9:00 am and 10:00 a.m. on the day of the meeting not read into the record will be submitted into the minutes by the clerk or designee and shall be forwarded to each commissioner by email. Speakers should always talk directly into the microphone and begin by stating their name, full address and the name of any organization they represent. Abusive, profane or derogatory language, holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.

Public Comments: April 25, 2023- Unread Emails

1. *Laura Kearns (No Address)- Good afternoon, I'm a DeKalb county resident and asking that Intrenchment Creek Park be re- opened. Also it is time to lift the veil of secrecy and have more open communication to the public about what's going on with the land there. I'm asking the county to be better stewards of the land and resources in general. The land entrusted to the county is not for private gain.*

2. *Ed Williams (No Address)- My Name is Ed Williams, I have lived in unincorporated south DeKalb for over twenty years. I am the chair of the group Concerned Citizens for Effective Government. It is my understanding the County is planning another SPLOST referendum in November without providing any details regarding costs and projects to be funded. Any SPLOST agreement should anticipate and plan for any future additional municipalities being created in DeKalb County. What activities, services, or facilities will the County undertake or provide? It can never be a valid county purpose to provide revenue to a municipality, because municipalities are not citizens of nor creatures of counties — they are an entirely different form of government. What plan does the County have to make sure that unincorporated residents be treated equally regarding equal protection and due process of the revenue and project funding? The County should be careful in how it implements the proposed SPLOST. There have been lawsuits filed in the past regarding E-HOST and SPLOST and the County would be well advised to tread carefully regarding this matter. All residents should be taxed uniformly, No county tax revenue should go to a municipality, and all taxpayers should be treated equally. As the SPLOST voted on in November 2017, I have a huge concern with the use of the unincorporated residents' portion of the revenue to pay for what I consider to be county-wide projects where the municipalities are not sharing in the cost even though their residents use the services and facilities equally with unincorporated residents. I believe that government should treat all its citizens equitably and that the government should be transparent and its officials held accountable. The 2017 County SPLOST method and formula used were not equitable to all the residents in both unincorporated and municipalities of DeKalb County. There is a disparity in the application of the SPLOST tax funds. The SPLOST legislation HB215 passed in 2015, and SB143 passed in 2017 in hopes that we could find a more equitable solution to address the county-wide projects being funded by unincorporated SPLOST revenue. There has never been a tax that the DeKalb Government didn't like. The 2017 SPLOST voted on by the residents of DeKalb County was the first in its history, even though the SPLOST has been around since the eighties. The SPLOST was voted on by all the citizens of DeKalb, and it was divided up with the other 13 municipalities excluding the Atlanta, portion of*

DeKalb County. I am certainly sure that you are aware that a sales tax voted on at the county level should be shared fairly throughout the district across the municipalities. The annual sales tax revenue for SPLOST was expected to be over 100 million a year. The total SPLOST revenue for the 6 years was expected to be over 638 million, where 388 million is to go to unincorporated DeKalb County. The County divided the SPLOST revenue up by population, where the unincorporated district of DeKalb of 431,250 residents will receive about 60.94 percent of the sales tax revenue for 6 years. I do not think the allocation of SPLOST money as it relates to the portion allocated to repair the courthouse, fire department, and other facilities that are used by the entire county should only be carried by the unincorporated residents' portion of the SPLOST sales revenue. The future obligations of SPLOST proceeds should be shared by more DeKalb residents certainly more transparently and equitably. The Powers of all public officers are defined by law and all persons must take notice thereof. The public may not be estopped by the acts of any officer done in the exercise of an unconferrred power. O.C.G.A § 45-6-5. Thank You

3. Donna-Margot Wilson, 795 Stonebrook Dr. Lithonia 30058- This is just a brief synopsis of my water problem with Dekalb County. I have lived at the above address since 1993. I have always received a water bill from Dekalb County and I have always paid the water bill. Sometime in 2017 I received a \$7000 plus water bill. I have spoken with Angela Baskerville on several occasions about rectifying the inaccurate billing but as of today it has not been resolved. She suggested arbitration. I sent an email requesting arbitration on March 2022 and I am yet to hear back. Incidentally, in May 2019 my water meter was changed by someone representing Dekalb County and Ms. Baskerville has denied that it was ever changed. Water is a necessity for life, and I live in a county where paying for water is difficult. Dekalb county watershed and other elected officials who sit by and do nothing want to place the blame on the people of Dekalb County. No one who lives here creates their own bill. The problem begins with Dekalb County watershed. The right solution would be to fix the broken watershed system and then go from there. Respectfully,

4. Cuong Nguyen, 1375 Southland Vista CT NE, Atlanta, 30329-In October 2021, our household at 1375 Southland Vista CT NE received an erroneous bill of 73,000 gallon of water for one billing cycle that is 25x times more than our normal consumption, which results in ~\$1400 in bill for the cycle. Our usage has never gone over 5,000 gallons of water for any cycle since we lived there, before or after that cycle. Dekalb watershed delayed the bill and data collection process for that period when we opened the dispute that resulted in no consumption data being collected for that cycle. All of our other cycles has proved that our average

consumption is only about 3000 gallon after that cycle but that erroneous bill has not yet get corrected nor resolved. We have also seen many other households had similar issue of one huge billing for one cycle without any leak or repair or explanation. We request Dekalb Watershed be responsible for the delayed response & erroneous bill that cannot be our actual usage in any possible ways and clear that bill. Regards,

5. Joe Peery, 1674 Flat Shoals Road SE Atlanta, 30316- County Commissioners and CEO Thurmond, The citizens of Dekalb County demand that you re-open our Intrenchment Creek park immediately. Your claims that the park is unsafe because of nail boards and fentanyl syringes is ridiculous. Those of us who have visited the park regularly for years know that the biggest threats to our health and safety have come through the destructive acts of Ryan Millsap and his hired assistants who have destroyed the pavilion, torn up the public PATH, bulldozed dozens of trees, including fruit trees that provided food to the public, and placed barricades blocking entrance to the park. Those acts are illegal in a public park, and broke the agreement that Millsap (under the name Blackhall) has with Dekalb County to keep the park open and available to the public until the new park is ready. It is far from ready, and the land swap is still under scrutiny in an ongoing law suit. The biggest threat to our health and public safety, by far, has been repeated violent attacks by police. Everyone should know that the protester known as Tortugueta was shot and killed by Georgia State police in our Dekalb County park. The many people who have been harassed, arrested and jailed indefinitely by police have committed no crime, other than simply being in our public park. These crimes are on your shoulders, and it is up to the Dekalb Commissioners and CEO Thurmond to right these wrongs, not by closing the park, but by protecting our citizens rights to enjoy our park without harassment from public officials. OPEN OUR INTRENCHMENT CREEK PARK NOW!!

6. Ralph MacDonald, 3212 Bluebird Lane Decatur, GA 30032- My name is Ralph MacDonald and I am a farmer in Belvedere Park. I am here to ask you to re-open the site known as the Weelaunee People's Park. The park was shut down by ED Michael Thurmond, against a judicial order, as it was deemed unsafe. Before it could be re-opened, construction crews were sent in, despite the "danger." The hypocrisy and raw abuse of power is staggering. It is worth noting that your department of planning has illegally forbid this county's soil and water supervisors from entering the cop city site due to "intentional booby traps," but again, safe for construction workers. I would bet anything there are no safety trainings, insurance requirements, or hazard pay that go along with the working of a site declared a public hazard. Because we can all see who is held to absurdly harsh criminal statutes and who is free to do as they please no matter

how many people they hurt. If you are not compliant with your own laws, how can you say that you are working for law and order? If you allow the sale of the people's natural assets to corporate interests for destruction, then you are a collaborator with those who terrorize us and degrade our land. How do you expect to be a part of our community, much less a leader in it? 7. Ian Garvey, 64 Sycamore Station 30030 Decatur, Ga- Re-open the park! The part of the park that was previously opened to the public has had large machinery drive through the area. Video evidence was captured by an anonymous source. There are tons of trees down including mature pine forest and young hardwoods. Weelaunee is home to more than 150 species. D. 10:00 A.M. PUBLIC HEARING

Citizens may speak for or against an item that is considered by law to be a zoning ordinance and each side will have ten minutes to present its case. Citizens may also speak for or against an item that is placed on the public hearing agenda but is not a zoning ordinance. In that case, each side will have five minutes to present its case. In the event there is more than one speaker per side, speakers must divide their time in order to complete their full presentation within the ten-minute time allotment, or the five minute time allotment. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to leave the podium area. Prior to speaking, a speaker shall complete a speaker card and present it when approaching the podium. If a speaker has any documents for the commissioners, the speaker shall provide 10 copies when approaching the podium. Seven copies are for the commissioners and the remaining copies are for the planning director, the county attorney and the clerk. In all zoning ordinance and traffic calming cases, staff shall make their recommendation for action to the Commission first followed by applicants or citizens speaking in favor of the item. Applicants in zoning ordinance cases shall have the right to reserve time for rebuttal. Opponents of a zoning ordinance item shall have no right of rebuttal. For all other items placed on the public hearing agenda, applicants or citizens speaking in favor of the item shall speak first followed by opponents of the item. Once the citizens have finished speaking, staff shall make a recommendation for action to the Commission. At this point, citizens are no longer allowed to speak unless called to the podium by an individual commissioner to answer questions or provide information. Speakers should always talk directly into the microphone and begin by stating their name, address and the name of any organization they represent. Abusive, profane or derogatory language will not be permitted. Holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.
