2. Sarah Aldama, 5078 Crowe Dr. Smyrna, GA 3082- My name is Sarah Aldama. I am an estate gardener working in Atlanta and living at 5078 Crowe Dr. Smyrna, GA 3082. I have also worked in partnership with the forest service, performing rare and native plant surveys out in the high deserts of Arizona. I am writing to you as an ordinary citizen and as a land professional. The 500 acre old-growth forest (over twice the size of Piedmont Park) is an ecological record of what all of Atlanta used to be. Companies now are seeking to reduce the parcel by half and to heavily pollute what conservation land is left, further justifying land degradation down the road. While enjoying the trails available at the park, I have seen several native plant and bird species, including what is believed to be the red-cockaded woodpecker. This endangered species relies on older pine forests like the one present within this complex old-growth forest. In my line of work, it is understood that many endangered species often take refuge in the same place as a response to nearby habitat disturbance. This biologically diverse forest stands today as a wildlife sanctuary and deserves the respect of a completed, peer-reviewed environmental impact study. The study already done seems to have been pushed through the system without proper accountability. Help us, the greater public, enjoy this beautiful, intact park for generations to come. Let this city continue to be the city of trees. With great respect,

3. Stephen Binney (No Address)- Good Morning Commissioners, Mr Bradshaw, I was disappointed when I was not announced as your new Charter Review Committee selection last week but I was not surprised. Someone with high ideals and new ideas can be a dangerous appointment, like a steppin' razor. Everybody who is eligible please vote today. If we are to change our community for the better you must vote. Vote like your life depends on it because it does. Find someone who shares your ideals and brings new ideas to the table. Last Thursday, May 19th, was the 97th anniversary of the birth of Malcolm X, one of our most vocal advocates for black empowerment in this country. His mother, Louise Little, became the National recording secretary for the Marcus Garvey Movement which commanded millions of followers in the 1920s and 30s. His father was a Baptist minister and chapter president of The Universal Negro Improvement Association who appealed to President Hoover that Marcus Garvey was wrongfully arrested. Earl's civil rights activism prompted death threats from the white supremacist organization Black Legion, who killed him in 1931 lying his body across the town's trolley tracks. Police ruled the incident an accident. Some things never change do they? Or have they? Let's see. While it is true that the poverty rate among blacks has fallen from 34% to 22% over the last 50 years, it is still over two and a half times the white poverty rate of 8%. One in 5 blacks living in poverty is unacceptable. 13.4% of the US population is black. 1.4%, less than 17,000, of the top one percent in this country are black. The top white 1% households have a median net worth of \$8.3 million, whereas the top black 1%, have a median net worth of \$1.2 million. To be in the top 5%, a black household would only need a net worth of \$356,000. In contrast, white households with the same \$356,000 in net worth represent nearly 30% of white households in America, Helping blacks become home owners and business owners is the most viable way to increase their net worth but Dekalb County government seems reluctant to do so. Dekalb County, a majority black county, continues to give the majority of our tax abatements to white developers and spend our tax money on improving the sewer capacity for a white owned company like Pepsi, who finally

started a black awareness program in 2021 in response to pressure after the killing of George Floyd. Or Blackhall Studios, owned by a white millionaire real estate developer, who immediately sold it to a multi-million dollar white owned investment firm. How can a black person get a break in this majority black county? We even do our banking with Wells Fargo who has been redlining black neighborhoods across the country and in Dekalb County for decades. If things are changing it is certainly not fast enough. Waiting for riches to trickle down will not suffice. We must demand, work, and fight for economic equality. Civil Rights are good, voting rights are necessary but without economic equality how much are they really worth? Thank you for your time and consideration,

4. Penimah (No Address)- "I am here today as a concerned citizen, as someone who loves nature, and as someone who would hate to see the destruction of the beautiful, important Atlanta Forest. The Atlanta Forests are some of the last breeding regions for amphibians in the region as well as important migrating grounds for wading birds. Hundreds of species of wildlife call the Atlanta Forest home. What will happen to them if the forest is destroyed? What will happen to them if you destroy their home!? They will die, and Atlanta will have contributed greatly to the climate crisis and ever growing species extinction. The only thing that will result from the destruction of the Atlanta Forest in favor of building cop city is that the city will become less welcoming, less filled with life, less in tune with nature, and will become more violent and more polluted. Atlanta citizens clearly don't want this forest destruction to take place. That has been made apparent from the hours of public comment. Stop favoring profit, stop favoring politics, and start advocating for the citizens you serve. Do not grant approval for the land disturbance permit."

5. Trey Morrow (No Address)- My name is Trey Morrow and I'm here today to ask the Board of Commissioners to deny the land disturbance permit that Atlanta Police Department has applied for. I am also asking DeKalb County to cancel their land trade agreement with Blackhall Studios who would destroy a large portion of the so-called Atlanta Forest. I am a filmmaker by trade. I have produced and directed music videos, commercials, documentaries, and short films and I have been doing this for over a decade now. I have never once cut down a single tree to make a film. Blackhall Studios can put their soundstage somewhere else that doesn't require destroying the local environment and killing countless frogs, snakes, squirrels, bugs, birds, and other wild animals in the process. Your constituents want the the forest to remain. As far as the land disturbance permit applied for by APD: do you really want to allow a police department that doesn't even have jurisdiction in your county to build a massive training facility here and cut down potentially hundreds of acres of precious forest to do it? Be on the right side of history. It would be a shame to have to tell your kids and grandkids that you were a part of the council that allowed the forest to be destroyed. Please deny APD's permit request and cancel the land swap with Blackhall Studios. Protect the Forest. Thank you for your time.

6. Samuel Parker Short, 5233 Fontainebleau Ct. 30360 Dunwoody Ga- Does the City of Atlanta need a new training facility for its public safety officers? Yes. Should that facility be built at the expense of Dekalb residents? No. The deal that has been crafted takes advantage of the low income and underserved communities surrounding the South Atlanta forest. This deal was not crafted with the interests of Dekalb residents in mind. The City of Atlanta has imposed a financial and social burden upon our County, targeting an underserved part of South Dekalb to save itself money while pursuing better services for their own city. Our board of commissioners should look to pursue better services for our residents, and should advocate for the interests of Dekalb residents whose voice has not been fully considered in this process. Please use your voice and your

vote to stop this project and advocate for those you represent, instead of another government entity. Dekalb is being taken advantage of in this deal, and the community is loudly saying. NO. Advocate for your constituents not the Atlanta City Council and the APF.

7. Ysabel Martinez (No Address)- To whom it may concern- the land disturbance permit is in violation of the requirements of the legislation. The community has not been given site plans, and adequate environmental testing not conducted. You will be perpetuating the environmental racism that ravages the South, and country as a whole.

8. Christian Wetzel (No Address)- I am a Dekalb county resident that vehemently stands against the tree cutting and land clearing in south Dekalb. Clearing an undeveloped green space to make room for unnecessary police training grounds stands against every tenant of environmental stewardship and community care. When the last forest is gone and the last creek runs dry our children will ask us why we let this happen. Not one tree and not one blade of grass. I write comment this from outside the closed doors of this public meeting.

9. Samantha Severin, 2185 second avenue Unit B Decatur GA 30032 - Hello, thank you for taking my comment. I am writing in opposition to the police training facility. Tearing down the forest to make room for this facility WILL create the conditions for flooding. This will affect neighborhoods of ALL incomes. Furthermore, we have seen NO evidence that harsher policing reduces crime. What we do know reduces crime is affordable housing, fully-funded schools, and social services. If the intent is to reduce crime, building this facility will not produce those results. Tearing down the forest creates the conditions for deadly floods. The police training facility is a great idea if we want our homes, schools, and businesses to be destroyed in a flood. In addition, there is no evidence that a more militarized police force has any impact on lowering crime. There is no upside to this project. Please deny the APD permit. Whatever corporate money is at stake is NOT worth destroying the forest. If that forest gets torn town, the city will become UNINHABITABLE. We are talking drastically higher temperatures and floods, which will impact every single resident of Decatur, Atlanta, and surrounding areas. Every person, every home, and every business will be at risk of destruction if the forest disappears. Do not approve this permit. The reason Atlanta doesn't suffer the drastic effects of flooding that other major cities experience is because the south Atlanta forest protects us. If it goes, we do not have the infrastructure to deal with the floods its destruction will cause.

10. Brittany Wages, 1866 Iona Dr SE Atlanta Ga 30316- I am writing from outside the "public" meeting to ask the Board of Commissioners not to approve the land disturbance permit for APF. Dekalb County residents were not given a chance to have their voices heard on the destruction of our natural spaces. APF's plans do not benefit the citizens of Dekalb county or metro Atlanta as a whole and would instead subject us to increased pollution, noise, and overly militarized police presence. The environmental impacts alone should be enough to reject this proposal. South Dekalb isn't a dumping ground for destructive projects that Atlanta officials falsely claim a need for. Our children deserve to grow up in the "City in the Forest" that we chose as our homes.

11. Johnny Lukewarm (No Address)- The APD training facility has made its way through the approval process without remote democratic support. Worse yet, APD has lied about the proposal's environmental impact, promising environmental and social disturbances far beneath reality. Granting permit #1245564 will be ruinous for Atlanta communities and will further our city's slide into violent carceral hell. Stop cop city! Do not

approve permit #1245564!

12. Alison Clark, 1691 Boulder Walk Drive Atlanta, GA 30316- Good morning, I am writing as a resident of the Boulder Walk Community - the community sharing a property boundary with the City of Atlanta property slated to become the new Atlanta Public Safety Training Center. The training center facility is in many ways the best option for our community in that it is being constructed as a campus with public use aspects that will allow for community engagement, usable trails, and added connectivity. Even more, the development means that the current bomb range located 500ft. from our community will move a 1/2 mile away with barriers to help mitigate noise impacts on the surrounding communities and bullet catch devices to allow for a more environmentally friendly operation. Community input has led to the removal of explosives from the site as well as site plan updates that allow the facility to fit seamlessly into the community and work to the benefit of those living in close proximity. I know there has been opposition to the project; primarily from those who wish to see the land preserved as green space and those who are concerned about the state of policing in the United States. While I understand the considerations of these groups and even share some of their concerns, I feel it is unrealistic to expect the land to remain unused and/or allow for continued trespass of individuals treating the property as public land. Instead, the projected use incorporates usable green space and legal public access. As for the state of policing in the United States, there are some serious problems that undoubtedly must be addressed as the bad acts of some have exposed challenges in policing. The solution requires the most robust training possible and enhanced engagement between community and police. This state of the art facility allows for just that and is a step in the right direction. While I am not writing in my capacity as such, it is appropriated for me to disclose that I serve as the Chair of the Community Stakeholder Advisory Committee for this development. Our work has allowed and will continue to allow the project to move forward with community input as a prioritized consideration, thus allowing the impacted community to shape the project in a way that can work for all parties involved. With that, I urge you to vote in favor of the permits required to move this project forward.

19. Savannah Denning (No Address)- Hello, My name is Savannah Denning. I have been an Atlanta resident for 8 years and a Decatur resident for 4. I am a certified permaculture designer, a certified sustainable urban agriculture technician, and I hold a dual degree in political economics and environmental horticulture. I have spent the last 7 years involved in green industry and sustainability efforts in this area. I am asking the board to deny land disturbance permit #1245564, which allows tree clearing in the south river forest. This land, perhaps the last and largest unprotected wilderness area inside the perimeter, has intact ecological function. It stores rainwater in its deep untouched debris layer, preventing flooding of all the surrounding communities. Grading removes, destroys, and compacts the living soil. The deep forests condition the air, cooling temperatures by as much as 20 degrees. These trees are literally the stored carbon breaths of our ancestors. The land surrounding them is sacred and has a deep, wounded history of being stolen, becoming a site of oppression as plantations, then as a prison farm, and now through environmental racism in the polluted soils and waters... are we supposed to accept the destruction of this forest? No. The forest is trying to heal this history of oppression with an interconnected riot of life. I have personally seen puddles on a foot trail in this forest so full of life that they contained hundreds of tadpoles nearing adulthood. Doing your part to save this treasure by saying no to land disturbance permit 1245564, is an action i believe this board must take, for the safety of our peoples and our descendants. I have included pictures so you can see what you are choosing. 1. A weaving and stitching depicting the land hung in the forest as an art exhibition. 2- 3 The forest after grading. You can see a "priority tree" which has been "saved" in further detail in picture 3, demonstrating the inadequacy of the ordnance in protecting life. This is what approving LDP 1245564 will do. 4. The forest, this site slated for destruction and is not 1000 feet from the raised sites in pictures 2 and 3. This is what denying LDP 1245564 will protect.

20. Bee Johnson (No Address)- Good morning, I am a concerned resident writing to express my complete opposition to the proposed land disturbance permits requested by the APD in Dekalb County. The proposed project of the APD, "Cop City," is not the kind of project we want in our county (or any county). The forest and land that would be "disturbed" are crucial for containing storm waters and soil erosion and for mitigating the effects of pollution and climate change. Furthermore, this is not a project that supports our community—we want funding for education, health care, and housing, not an increasingly militarized police force. Dekalb County must decide which side of history it wants to be on—that of the community, the Earth, and justice, or that of destruction, violence, and oppression. Yesterday, my water tasted sulfuric and it felt like a preview to what's to come in this community if we allow cop city to destroy our watershed. Water is essential to life, and I noticed that my older is already depend on bottled water instead of our natural resources. I know that if this project goes through it will affect the water that they bay then, cook with, used to clean their bodies before they take intravenous medication for insulin and other ailments. I am pleading with the commissioners and next generation of representatives to stop this project in its tracks and consider creating a heritage site, like the cultural heritage corridors of the sea islands, or the or a state park with this site instead of a cop training facility. For more in the historical significance of this area,

please check out this episode of archive Atlanta about the old prison farm and it's history as a burial ground for zoo animals, a prison labor camp, and also a site of Indian removal. As an African-American human rights activist, archaeologist, and environmentalist, I am horrified to still be having to make public comments about this situation. It seems abundantly clear that the scientists, elders, and youth are together in saying - Stop Cop City Now. I hope you will listen to the podcast to learn more about the significance of the space and why it should not be degraded. God damn all the police working to protect their dignity. There is nothing but shame for the violence they carry out by enforcing racialized capitalism. Let me know when a DeKalb county comish wants to talk at all about immediate injunctive relief of any kind. This is all blood on your hands. STOP COP CITY. STOP THE SWAP. Will you be yet another public official to act out of step with the consent of the governed? Do something that would make your grandma or children proud of you.

23. Brad Beadles (No Address)- The Atlanta Police Foundation has not performed a Phase 2 Environmental Site Assessment according to ASTE standards. Instead, they have only performed a Limited Site Investigation, which does not meet the standards set forth by ASTE. APF is actively defrauding their investors, the county, and the residents by claiming that they have completed a Phase 2 environmental study, when it is clearly not the case. In the LSI report by Terracon, they specifically mention that the LSI is NOT in fact a Phase 2 ESA. The City of Atlanta and the Atlanta Police Department have a long history of destroying and polluting this piece of property. They currently and regularly detonate bombs in the forest and shoot firearms towards Intrenchment Creek in two separate outdoor firing ranges that do not meet the EPA standards set forth for outdoor shooting ranges. The proposed APSTC will only increase the amount of heavy metal pollutants being dumped into the soil and the water. They cannot receive a land disturbance permit for such reckless and destructive behavior.
