## **Justification:**

The DeKalb County Police Department is moving forward with the implementation of a state-of-the-art Real Time Crime Center (RTCC), a critical investment in public safety that will transform how we prevent, respond to, and investigate crime. This initiative represents a major expansion of our technological capabilities through significant enhancements to the existing Flock Safety system, which has already proven to be a powerful tool in crime prevention and case resolution.

The project includes the addition of 308 new cameras, expanding our current network of 183 License Plate Readers (LPRs), as well as the deployment of Gunshot Detection Technology, Flock Operating System with AI-driven real-time analysis, and Flock 911, which provides law enforcement with direct, real-time access to 911 calls. This integration will allow officers to respond more quickly, more effectively, and with better situational awareness.

Equally transformative is the addition of two Drones as First Responder (DFR) units, which will provide rapid aerial support, enhance officer and community safety, and allow law enforcement to assess threats before units arrive on scene. Together with the RTCC, these technologies will reduce response times, limit escape routes for offenders, and strengthen coordination with partner agencies across jurisdictions.

This expansion is not just about technology it is about protecting lives and strengthening community confidence in public safety. By investing in these advanced systems, DeKalb County is ensuring that officers are better equipped to confront evolving threats, while residents and visitors alike benefit from safer neighborhoods, faster emergency response, and a stronger partnership in the fight against crime.

Public safety is the foundation of a thriving community. Through this investment, DeKalb County is making a clear and unwavering commitment: to protect our residents, safeguard our future, and deliver the highest standards of service in modern policing.
