Justification of Proposed Changes: The repairs to Filters 1A, 1B, 11A, and 11B were recommended by the manufacturer, who is considered the expert of filter design and construction. The specifity of the repairs was not described in the scope of work (ITB 17-100821) because there was no way to know what changes would be recommended before the manufacturer's inspection took place.

The replacement of the six actuators is required to operate the filters which is the end goal of this scope of work.
The removal of media in the effluent piping of Filter 1A was necessary because this media was only in the effluent piping due to the failure 5-years ago. There should be no media in the effluent pipes under normal operation.
Re-Mobilization is required because the Contractor left the site due to inactivity beginning on February 28, 2018.
Additional items identified by RFI's or the Construction Management Team are required to complete the work as intended by the ITB.
