1. Bidder stated, "Located on drivers side". Having the controls on the curbside, puts the

MHC Kenworth Bid #3 is not acceptable and unit bid took multiple exceptions to the minimum bid
specifications for multiple body and hydraulic requirements that include:
B. Body Construction:
3. Bidder stated, No (3/16" GR50). 3/16 inch steel is smaller gauge steel than ¼ inch steel. We
need the 1/4 inch steel due to the floor, takes a lot of abuse from garbage and debris sliding back and
forth on it. The floor will wear thin after a while. The thicker steel will last longer and is less likely
to get punctured.
7. Bidder stated, No (Rigid Ladder). We need a ladder on the side of the vehicle so the operator
can access behind the blade through a door opening on the side of the vehicle, and remove debris
that has passed by the side of the blade. When debris gets behind the blade, it gets caught and jams
up the retractable blade, hindering the operation of the blade. It can also damage the hydraulic hoses
and fittings. Without the ladder the operator has no way to get in behind the blade and remove the jammed debris.
S. Warranty:
2. Bidder stated, "I year". I year warranty for hydraulic system is low. We can get a much
better warranty through McNeilus, like 2 years on the pump and spool valves, and 5 years on the
