Commissioner Gannon,

I have represented DeKalb County's District 2 on behalf of Commissioner Rader on the planning commission for nearly six years. For several of those years my wife, Sara, was living and working in D.C. About a year ago, however, Sara's work brought her back to Atlanta. Since that time we've been slowly working towards purchasing a house.
