Stephen Binney, 1083 Seville Drive - I hope that all are well, especially the citizens of DeKalb County. Without their help, things would be a lot worse. My thoughts and prayers go out to everyone. The County has been amassing a rainy day fund over the last few years for possible future disasters or hard times. If this pandemic does not qualify as a disaster I don't know what does. The small business owners, who are the backbone of our county, service workers, the homeless and especially our senior citizens are all in need of extra help at this time. 41% of children in zip code 30032 live in poverty. Over 50% of families in zip codes 30032, 30034, and 30035 are financially unstable with the head of many of these households over the age of 55. Now is the time to use some of our rainy day funds and I encourage the CEO and the commission to do so. This may shock some of you but I agree with Mr Thurmond. Our front line employees do deserve hazard pay and maybe even additional comp time. However, I do believe this is something that needs to be approved by the commission and am disappointed that it is not on today's printed agenda. The commissioners should also be looking into the County's future financing. There is the very real probability that property valuations will be lower next year due to the current recession. We should evaluate this year's budget revision and next year's budget with this in mind. Perhaps no extra commissioner's discretionary funds this year and a cut back for next year. Sales tax collections may end up being down anywhere from 10 to 25% for the rest of this year. The County's SPLOST collections are currently 3% under projections. A total of 10 million dollars short over the six year span of the tax. That amount could climb to 20 or 30 million dollars depending on how long this pandemic lasts. Decisions will need to be made about which projects to fund and which ones to be put off till later. I ask each commissioner to not spend any of their 1 million dollar discretionary SPLOST funds until the full economic impact of this pandemic are known. I believe that promises made to the citizens of DeKalb County are more important than the desires of individual commissioners are during these extraordinary times. MARTA's revenue will also be falling. Promises and agreements made in the 15th amendment will be reevaluated. Be prepared to put your desired projects in order and fight for the DeKalb County that has been ignored in the past by MARTA. Finally, there is item 0400 on today's agenda. During discussion of this item could you explain what a Personal Services budget is and why it needs to vary by as much as 5% each month for each department?

John Walters (no address), DeKalb Senior Resident Unincorporated DeKalb - During 30 Mar online Town Hall, please update Residents on status of two DeKalb essential transport programs:

- 1- Transport Residents [with no transport or Marta] to medical appointments.
- 2- Transportation Voucher Program (TVP) where Senior Residents pay their own choice of driver with a DeKalb voucher. These drivers are frequently friends, neighbors, family, or home care takers.

Since above #1 general transport is reduced to dialysis and only a few specialty appointments, can TVP vouchers be used for medical appointments during COVID-19 reduced operations? Sandra Morrow and Mrs. Higgins have previously declared TVP vouchers for "social" purposes only; and medical trips will not be reimbursed if voucher submitted to DeKalb.
