PURPOSE:

To consider extending an existing exemption on the collection of sales tax in Georgia on tickets to certain fine art performances or exhibits held in a venue owned and operated by a 501(c)(3) tax exempt organization beyond its current expiration of December 31, 2022.

RESOLUTION

A RESOLUTION BY THE GOVERNING AUTHORITY OF DEKALB COUNTY, GEORGIA, REQUESTING THE GENERAL ASSEMBLY CONSIDER REVISION OF O.C.G.A. SECTION 48-48-3 (100)(C) TO EXTEND THE CURRENT SUNSET PROVISION AND FOR OTHER LAWFUL PURPOSES

WHEREAS, the Governing Authority of DeKalb County requests that the General Assembly work to support legislation amending O.C.G.A. Section 48-48-3(100)(C) to extedn the current sunset provision; and,

WHEREAS, O.C.G.A. Section 48-48-3(100)(A) exempts certain sales of tickets, fees, or charges for admission to fine arts performances or exhibitions conducted within a facility that is owned or operated by an organization that is exempt from taxation under Section 501(c)(3) of the Internal Revenue Code or a museum of cultural significance from taxation; and;

WHEREAS, O.C.G.A. Section 48-48-3(100)(C) provides that the exemption provided for in O.C.G.A. Section 48-48-3(100)(A) shall expire and stand repealed on December 31, 2022; and

WHEREAS, the tax exemption provided for at O.C.G.A. Section 48-48-3(100)(A) is integral to the ability to attract and stage fine arts performances and the potential expiration of such tax exemptions could make attracting and staging such performances more difficult and expensive.

NOW, THEREFORE, **BE IT RESOLVED** by the Governing Authority of DeKalb County, Georgia, hereby requests that:

- 1) The General Assembly amend the terms of O.C.G.A. Section 48-48-3(100)(C) to extend the sunset of such provision beyond the current expiration of December 31, 2022.
- 2) The Executive Assistant or his designee deliver a copy of this Resolution to each member of the Georgia General Assembly representing a portion of DeKalb County.
