Large Constitution (Section 1)	
Allied (non-Deere)	Allowed, can only be sold with a contract item. Allied items are products, implements, attachments, accessories, parts or bundles not manufactured by John Deere that are requested by the customer to complete the purchase of John Deere equipment awarded on contract.
Special Delivery Obligations	FOB Destination, Freight Prepaid and Added. Factory to dealer freight and dealer to customer freight are to be quoted and invoiced to the customer.
Fees	Dealer quotes non-factory items, installs, PDI, and local delivery. Dealer provides customer walk around at time of delivery free of charge. Dealer margin is 7% MDP for CE products. Sourcewell has a 0.5% admin fee based on contract item selling price (not dealer items).
Financing	A John Deere Municipal Lease grants full ownership at the end of the lease term. Arrangements are made between the dealer and John Deere Financial. Notice of lease/provider must appear on the quote and customer purchase order. Operating Leases: If the selling dealer is not authorized to sell direct on the John Deere Construction Retail Sales (JDCRS) contract, operating leases are not allowed. If the dealer is trained and authorized to sell direct on the JDCRS contract and the PO is written to the dealer, operating leases are allowed at the discretion of the dealer/financing company.
Multiple Unit Discount	Following additional discount applies to: like/self-propelled machines, placed at the same time, and on the same purchase order. 5-7 Units 1% 8-14 Units 2% 15-30 Units 3%
Non-contract (Deere)	Allowed, can only be sold with a contract item. Non-contract items are John Deere manufactured products, attachments, accessories, parts or bundles that are not on contract, but are requested by the customer to complete the purchase of John Deere equipment awarded on contract.
Rental	Not allowed on this contract.



Substitution	Not allowed on this contract.
Trade-in	Allowed, trade-in items must be clearly labeled on the quote and customer purchase order as "Trade-in". Dealer determines the trade-in value for customer consideration.
