Houston, 5627 Stonington Trace Pkwy Stone Mountain, GA 30087- Mr. Rudolph Bradford's blatant disregard for the law and mistreatment of innocent animals has gone on long enough and DeKalb County needs to enforce the cease and desist ruling of the judge that was issued on behalf of Rudolph Bradford. His lack of concern for the law and obstinate behavior will encourage others to willfully disrespect the law and feel entitled to make their own decisions. Ecclesiastes 8: 11-14 Because sentence against a bad deed has not been executed speedily, the heart of men becomes emboldened to do bad. • is also infringing on surrounding neighbor's mental and emotional health by disturbing and disrupting their peace of mind. Neighbors experiencing anxiety attacks as a result of gunshots from Mr. Bradford killing his livestock in a RESIDENTIAL COMMUNITY could and should lead to civil lawsuits! • Mr. Bradford is already running an illegal slaughterhouse in a residential community where people want to live in peace and quiet without fear of him mistreating or inhumanely killing and/or torturing an animal if the slaughter procedure is not quickly executed or professionally done! Based upon DeKalb County's Chapter 5 Animal Ordinance, Mr. Bradford is in violation of not providing adequate shelter Sec. 5-1. Definitions. Neglect means endangering an animal's health by failing to provide or arrange to provide the animal with food or drink if the animal is dependent upon a person for the provision of food or drink, or the act of restraining an animal in a manner that endangers the animal's life or health. Other acts considered to be neglect include, but are not limited to: 2) Leaving an animal outside and exposed to excessive heat or cold without providing the animal with adequate shelter or protection from the heat or cold, or exposing an animal to unsanitary conditions. Disposing of animal remains in an unsanitary way Sec. 5-1. Definitions. Unsanitary conditions means an animal living space, shelter, or exercise area contaminated by health hazards, irritants, pollutants, items, or conditions that endanger or pose a risk to an animal's health. Based upon DeKalb County's Chapter 5 Animal Ordinance, Mr. Bradford is in violation of slaughtering the animals in an inhumane way Sec. 5-8. Cruelty to animals. (b) The method used for killing the animal shall be as humane as possible under the circumstances. A person who humanely kills an animal under the circumstances indicated in subsection (a) of this section shall incur no penalty for such death. Proverbs 12:10 The righteous one takes care of his domestic animals, But even the mercy of the wicked is cruel. Mr. Bradford's defiant attitude displays a lack of regard for the life of INNOCENT animals and the LAW! Sec. 5-19. Enforcement generally. (a) As authorized by 1979 Ga. Laws 516, the police chief shall enforce the provisions of this chapter and applicable provisions of Chapter 13 of this Code. (b) Upon information learned by, or complaint lodged with, the police chief that an animal owner is in violation of this chapter, the police chief shall cause a summons to be issued requiring the owner of the animal to appear before a judge of the DeKalb County magistrate court, at a date and time certain, to stand trial for the violation. If a violation has not been personally witnessed by the police chief or other law enforcement officer, a subpoena shall be issued to the person making the complaint, along with any witness(es), to appear on the date and time set for trial, to testify on behalf of the county. (c) The police chief may respond to anonymous complaints of violations of this chapter. If the owner or custodian of an animal is unknown or not present, and such animal is upon the public streets, alleys, sidewalks, school grounds or other public places or premises, or is upon another person's property without permission or absent proper restraint, or is a classified animal as to which the registration, confinement or insurance requirements have not been met, the police shall immediately impound the animal in a facility designated for the detention of animals. Once impounded, the animal shall be kept for a period of time as set forth in section 5-22. Thereafter, if the animal is not claimed, the animal may be disposed of in a humane fashion in accordance with the provisions of O.C.G.A. § 4-11-5.1, et seq.

2. Dr. Ed Williams (No Address)- Good Morning Commissioners: My Name is Ed Williams, I have lived in

unincorporated south DeKalb for over twenty years. I am the chair of the group Concerned Citizens for Effective Government. What is the price of freedom? The War in Ukraine reminds us what it means to be a citizen and to be willing to give up one's life for freedom. I don't want to study war anymore, but freedom is worth it. We are reminded of the prophetic words of Dr. King who once said that "Injustice anywhere is a threat to justice everywhere" and let "justice runs down like water, and righteousness like a mighty stream." The People of Ukraine are not wrong, If they are wrong, the Constitution of the United States is wrong. And if they are wrong, God Almighty is wrong. If they are wrong, Jesus of Nazareth was merely a utopian dreamer that never came down to Earth. If they are wrong, justice is a lie, and love has no meaning. Today, we may be on the brink of another world war, so we must ask ourselves as citizens of DeKalb County are we ready, is the State of Georgia ready, and is the US ready to defend freedom and democracy around the world and here at home?? Dr. Martin Luther King noted that "[the ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy. The true neighbor will risk his position, his prestige, and even his life for the welfare of others." There are some things so dear, some things so precious, some things so eternally true, that they are worth dying for. And I submit to you that if a man has not discovered something that he will die for, he isn't fit to live." This is why we see in Ukraine the people seeking freedom from a tyrannical government that bands a free press and free speech. Where the citizens are jailed because they dare to speak out against the government. And where you can be detained and jailed without due process. This is why I love my country and freedom is worth defending. We must demand better accountability from government officials who have power because our freedom depends on it. We cannot take for granted the freedoms that we have, because they can be taken and lost for our posterity. Each link of the chain is important, because if one is broken then the system of justice is broken. We must hold government officials accountable in everything that they do that has an impact on your rights, property, representation, and wallet. When a government official abuses his authority as in Russia it can harm the entire organization and erode the faith and trust of citizens, in their government. One bad apple can spoil the whole barrel. The War in Ukraine reminds us why oversight is so important, As the commission, you must perform your oversight duty to ensure that government officials exercise their duty with care and honesty and have the proper training and resources to do their job correctly and with duty, honor, and care. When government officials find that they have acted wrong or in bad faith whether intentional or not, then their actions should be corrected. We have to ask ourselves how are we different from the Russian system and President Putin who has held power for over 20 years and surrounds himself with cronyism, officials who are indifferent to those that are suffering and incompetent people, All maintained by-elections that are not free controlled by the party are not transparent. Citizens who are afraid to speak out are punished or retaliated against if they dare speak out against the government or their political party and the government uses its authority, power, and public treasury to deny the citizens their right to petition their government, and where citizens have to pay to have access to basic resources such as clean water and are denied basic health services, and district lines are redrawn to deny citizens equal and fair representation. The responsibility to govern comes with great power and responsibility to do the right thing and exercise your power justly and with great care. This power must not be abused. We should stand for freedom and justice, and we should stand with the citizens of Ukraine. I believe that we as freedom-loving people of the US should support the freedom-loving people all over the world The winner will determine after it is over, who will control the resources, land, and run the government? The people will still have to provide for themselves. The question is under what type of system. Will citizens be free? Will there be fair trade? and Will it be a democracy? This is what is at stake. We cannot be blind to injustice and evil. I stand with the freedom-loving people all over the world. We cannot remain silent on the things that matter. We must stand

for the proposition that all freedom-loving people have the right to life, liberty, and pursuit of happiness, Thank You

- 3. Joy (No Last Name or Address)- Dear Commissioner: Nearly all the states provide by law that an animal must be "rendered insensible to pain" (e.g., made unconscious or killed) prior to being hoisted or shackled for slaughter. Most of these state laws also contain a religious/ritual slaughter exception whereby an animal may be killed by severing the carotid artery, causing loss of consciousness prior to be hoisted. About half of the states expand the definition of "livestock" to any animal used in the preparation of meat products. Even though the USDA passed the Federal Humane Methods of Slaughter Act of 1978, livestock (cows, pigs and others) are "still" being slaughtered as described below. This is a statement regarding the procedures that were taking place in the slaughterhouses in 1956 which are still being performed today due to lack of enforcement and greed. "Cattle, like horses, are slugged on the head with iron mallets. The first blow frequently fails to stun them – as they stumble, electric shocks force them to their knees so that they may be struck again and again. Calves, hogs, and lambs are strung up (conscious) by chains tied to their hind legs. When the chains slip or legs are disjointed and broken, they crash from high conveyor lines to slaughter house floors. The throats of the calves are severed by sawing motions; lambs are knifed behind an ear and slowly bleed to death; hogs with slit throats frequently pass still squealing into scalding vats." I have witnessed these violent acts as an advocate for animals through the eyes of the organization PETA and other animal advocacy organizations who capture these murderous acts in real time to provide the public with a "true and realistic" understanding of what really goes on in these slaughterhouses. The United States kills more than 60 billion animals each year excluding fish which are killed at an alarming rate of 200 million tons. Their lives are measured by weight not the weight they have on our planet's ability to function properly or the weight they have on us in bringing us joy and pleasure at the sight of their beauty. Seventy percent of the animals we farm live in factories. In the United States that number is 99%. In saying this, when we destroy nature we are destroying ourselves as we are all connected. One cannot function without the other. All of these animals have the ability to feel empathy and possess a soul just like your child or mine. This slaughterhouse is in violation of the Georgia State law and has already been issued a "cease and desist" order that has NOT been enforced by Dekalb County. Why not??? This will not go away and the voices like myself will continue to ring in your ears until you act and do your job as an elected official. You are only in your seat because "the people" put you there. Please do what's right and close this place down and remove these cows and place them in a sanctuary where they can live out their lives and place that owner in jail for violating the laws. I am not sure if you have ever been around these slaughterhouses, but you can hear the sounds of their screams. Do you really want a child who may live in the neighborhood to hear this and have that memory in their heads for the rest of their lives because it does stay with you. It is part of the reason I became a pescatarian. You can be that change we need in the world. I ask you to not only use your conscience, but to do your job as an elected official and enforce the laws that are already in place. You have the opportunity to do good and make the right choice. What will you do? Thank you for your time!
- 4. Soul Eubanks (No Address)- I am a DeKalb County resident who was recently made aware of Bradford Livestock, an illegal backyard slaughterhouse operating within minutes of my home and I am appalled to discover this slaughterhouse has been operating for over three years without the county shutting them down. As a tax paying Dekalb County resident it is disturbing to see that the cease and desist order hasn't been enforced in over 3 years. I strongly believe if this were virtually any other business ignoring a cease and desist order from the county, DeKalb's response would be much stronger and more swift. Would the county allow this

operation to continue if this location slaughtered over 4000 dogs and cats in the past 3 years instead of cows, pigs, sheeps and goats? This is a huge disservice to the residents who have to live near this slaughterhouse everyday as it negatively impacts our neighborhood and the Dekalb community at large. This slaughterhouse is a health hazard to our local community that negatively impacts Dekalb's soil, wastewater and decreases the property value of our homes. CEO Michael Thurmond, COO Zach Williams and Dekalb commissioners, would you allow an illegal slaughterhouse that is a health hazard to your family to operate next door to you for over three years? Would you allow it to occur in your neighborhood? Would you allow it to continue down the road from your child's school. Redan Elementary school is one block from this slaughterhouse and their students and teachers deserve more. The community is not confident DeKalb County has done everything in their power to shut this slaughterhouse down and we demand more. We are asking you all to do what is right and exhaust all possible resources in shutting down Bradford's Livestock.

- 5. Stephen Binney (No Address)- Good Morning Commissioners and Citizens of Dekalb County, The most important process in Dekalb County over the last 40 years is set to start a week from Wednesday evening and not much has been said about it and it is not being publicized by the county at all. The Dekalb County Charter Review Commission will start meeting, discussing, debating and deciding on potential changes in our form and structure of government. Do we want to remain the only county in Georgia with a very powerful CEO and weak commissioners or do we want a more equitable distribution of power in Dekalb County? How many commission districts should Dekalb County have? Seven, nine or more. Should we maintain super districts or not? I personally like nine districts, seven individual and two super districts, but your preferences may be different and now is the time and place to voice your ideas and concerns. How much transparency should Dekalb County provide to its citizens? Hopefully more than it currently does. CEO Michael Thurmond said he was surprised to find out that Dekalb County does not have a Code Enforcement department. Do you think we need one. If you think Dekalb County needs stronger code enforcement now is the time to make you opinions known. A stronger form of Code Enforcement can be established through the Charter Review process but you must take part in it. How much should Dekalb County's CEO and Commissioners be paid? Should commissioners be allowed to set their own salary? Should potential pay increases be tied to judges salaries? Were you shocked or surprised the last time they increased their pay? If you think the current process should be changed or modified, the Charter Review Commission is the place where this can be done. Is the Dekalb County Ethics Board effective? Does the county need changes in it's ethics process or stiffer penalties? What about whistle blowers? Are they champions of the people or tattletales? When someone goes to Dekalb County government with reports of graft or poorly run departments the County's response in the past has been to fire the person and pay them off in court. Do we need a provision in our county charter to protect whistle blowers from retaliation by the county? Are you satisfied with Dekalb County's current Contract and Procurement process? A process that has been audited and criticized for many years. Would you like to make some adjustments to the process? Now, is the time. These and many other things can be changed during this process as our County Charter is rewritten. Regardless of your views your impute during the upcoming Charter Review process can be one of the most important things you can do for you, your children, loved ones, and all of us in Dekalb County. Now is the time for action. Thank you for your time and consideration,
- 6. Dana Davis (No Address)- To whom it may concern, I am a resident of DeKalb County, and horrified about what I've recently learned. Bradford's Livestock is a slaughterhouse- in a neighborhood, right by a school. I know in March 2019 a cease and desist order was issued against this place. Areas where residents

live in DeKalb County are not zoned for slaughterhouses, so I am incredibly confused as to why it still exists. If it is not legal, and it needs to be removed. There is a number allowed for animals that are on a residential property, which is no doubt being exceeded. So my questions are this: 1) Why is this being ignored by Michael Thurmond, Zach Williams, and the DeKalb commissioners? 2) How come a cease and desist was ordered, but not enforced for over three years? 3) Since the safety of DeKalb residents is not being taken into consideration at all, what other things is this county willing to overlook while they suffer? Im sure the people that have power to change this would do a lot more if it were affecting them. Thank you, and I await a response.
