SUPPLEMENTAL AUTHORIZING RESOLUTION

WHEREAS, the Congress of the United States of America enacted the Water Infrastructure Finance and Innovation Act, as amended by Section 1445 of the Fixing America's Surface Transportation Act of 2015, as further amended by Section 5008 of the Water Infrastructure Improvements For the Nation Act of 2016 and by Section 4201 of America's Water Infrastructure Act of 2018 (collectively, the "WIFIA Act"), which is codified as 33 U.S.C. §§ 3901-3914;

WHEREAS, the WIFIA Act authorizes the United States Environmental Protection Agency (the "WFIA Lender") to enter into agreements to provide financial assistance with one or more eligible entities to make loans with appropriate security features to finance a portion of the eligible costs of projects eligible for assistance;

WHEREAS, pursuant to Article IX, Section V, Paragraph IV of the Georgia Constitution, the governing authority of the County is authorized to obtain loans from the federal government or any agency thereof pursuant to conditions imposed by federal law without the necessity for a referendum to be held therefor; and

WHEREAS, pursuant to Section 36-87-2, Official Code of Georgia Annotated, the County is authorized to participate in federal programs which provide federal loans and to contract with the United States and its departments and agencies; and

WHEREAS, the County has requested that the WIFIA Lender make a loan in the principal amount of \$[_____] (the "WIFIA Loan II") pursuant to the WIFIA Act and the terms of a WIFIA Loan Agreement dated April 26, 2022 (the "Loan Agreement") between the WIFIA Lender, as lender, and DeKalb County, Georgia (the "County"), as borrower, to be used to pay a portion of the Eligible Project Costs (as defined in the Loan Agreement) related to the Project (as defined in the Loan Agreement) pursuant to the application for WIFIA financial assistance received by the WIFIA Lender from the County on October 4, 2021 (the "Application");

WHEREAS, the Administrator of the WIFIA Lender has approved WIFIA financial assistance for the Project to be provided in the form of the WIFIA Loan II, subject to the terms and conditions contained in the Loan Agreement;

WHEREAS, based on the Application and the representations, warranties and covenants set forth in the Loan Agreement, the WIFIA Lender proposes to make funding available to the County through the purchase of the WIFIA Note (as defined in the Loan Agreement), upon the terms and conditions set forth in the Loan Agreement;

WHEREAS, the County will agree to repay any amount due pursuant to the Loan Agreement and the WIFIA Note in accordance with the terms and provisions of the Loan Agreement and of the WIFIA Note; and

WHEREAS, the Governing Authority (hereinafter defined) previously adopted and approved a resolution on March ___, 2022 (the "**Original Resolution**") which authorized the execution and delivery of the Loan Agreement and the WIFIA Note;

WHEREAS, after careful study and investigation, the County desires to approve the WIFIA Interest Rate (as defined in the Loan Agreement);

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of DeKalb County, Georgia and the Chief Executive Officer of DeKalb County, Georgia (collectively, the "Governing Authority") as follows:

- 2. The Governing Authority hereby confirms the existence and applicability of the Original Resolution and ratifies, restates, and reaffirms its representations, warranties, covenants, and agreements and all of the applicable terms, conditions, and provisions as set forth in the Original Resolution and as supplemented and amended by this Supplemental Resolution. Except where otherwise expressly indicated in this Supplemental Resolution, the provisions of the Original Resolution are to be read as part of this Supplemental Resolution as though copied verbatim herein, and provisions of this Supplemental Resolution shall be read as additions to, and not as substitutes for or modifications of (except as otherwise specifically provided herein), the provisions of the Original Resolution. Except as expressly amended, modified, or supplemented by this Supplemental Resolution, all of the terms, conditions, and provisions of the Original Resolution shall remain in full force and effect.
- 3. This Supplemental Resolution shall be placed on file at the office of the County and made available for public inspection by any interested party immediately following the passage and approval of this Supplemental Resolution.
