- 1. Stephen Binney, 1083 Seville Drive-Good Morning Commissioners, Mr Terry, I want to encourage you in your efforts to tie Dekalb County's pay wage to a national living index of some kind. The MIT index you mentioned in committee is a good one but there are others that could be used also. The fact that it can be specific to Dekalb county is very useful. The fact that it calculates \$18.17 as a livable wage in our county points to the high costs of living in urban areas and also how the time of \$15 an hour may be passing us by. Currently, DeKalb families of four need to make \$77,245 per year to attain an adequate standard of living. I hope that Mereda Davis-Johnson will note that two times \$36,200 dollars a year is only \$72,400 a year. Nearly \$5,000 less that what the Economic Policy Institute states is needed to live adequately. It was great to hear that SPLOST collections are exceeding expectations. It was sad to hear that even with this excess of funds Dekalb County is not going to be able to meet the road paving promises they made in the original contract. Only 270 of the promised 300 miles of road are going to be paved. Over 100% in tax collections but only 90% of the promised roads are to be paved. Have you told the affected people which 30 miles of their roads are not going to be paved as promised? Will these roads be included specifically in the next SPLOST vote? When the roads were first discussed, roads scoring 25 or higher, on a scale of 40, were scheduled to be paved. By the time the final proposal was put together that threshold had been raised to 30 and now even higher. Repaying roads was the biggest selling point of the first SPLOST and the county has failed on delivering it's promises. The first SPLOST proposal was put together by citizens during 2016, approved in 2017, and went into effect in April of 2018. It is due to expire in April of 2024. Have any citizen groups, neighborhood associations, or public meetings been held to allow the public to have a say in how SPLOST funds should be spent this next time? Our CEO and Commissioners believe they have earned our trust to spend our funds from the next SPLOST without public input and guidance. Have they? I do not personally think so. A short history lesson Mr Terry, the first SPLOST was written for five years and did not have any individually allocated funds for commissioners. The cities were asking for six years and the county agreed but did not have enough projects written down to spend all the money. The answer was to allocate those remaining funds equally to each commissioner. I wonder how many miles of road could have been repayed with that 7 million dollars. SPLOST funds should never have been and never should be allocated to individual commissioners under any formula, yearly or other. The sales tax is collected county wide and all decisions in the spending of it should be made by the entire commission. Giving that money to individual commissioners increases the chances of them spending the money to make themselves look good instead of improving the lives of Dekalb County citizens. - 2. Hadley Nobles, 3876 Emerald North Dr. Decatur, GA- Dear DeKalb County Commissioners, I'm reaching out to all of you as leaders of DeKalb County. I was recently a witness to an animal neglect situation in my neighborhood and ended up fostering the dog since the shelter is beyond capacity. Multiple neighbors had reported the abuse and neglect which resulted in over twenty plus interactions or attempted interactions with the owner by Animal Enforcement since May with no resolution. The dog had been living in a crate outside in the elements for several days at a time without food or water barking non-stop in extreme distress since May. When I became involved, I found the dog covered in her own feces and she had sores on her face and paws from being continuously kept in the crate. Eventually after months of warnings, the owner was charged with animal neglect. I'm not sure if the charge would have ever been brought forward had it not been for my insistence on follow ups. I am sharing my experience with you because cases like these are common in DeKalb County. This dog and similarly other dogs suffer from neglect and cruelty because our laws are not enforced. I understand the need to work with pet owners when they are open to help but right now warnings are given to no end without any progress. In my case, the owner did not change his behavior despite warnings over months.

Who paid the price? This abused dog who has no voice. We have a court date now and we'll see how long this step will take. If it is anything like other cases in DeKalb, then this dog will unfortunately be in the system for months. Who is paying the price for her neglect? - This abused dog, the foster, and the tax payers. Neglect and cruelty cases have a history in DeKalb County as being poorly managed and owners getting a pass. How do we expect this cycle to break without any consequences? I urge you to go visit our overcrowded county shelter filled with unwanted pets. We need to do better. These are God's creatures. And they have no voice unless we advocate for them. I believe there are solutions. Are you willing to do the work? Sincerely,

- 3. Markie Campbell, 2057 McAfee Road, Decatur, GA 30032- Dear Dekalb County Commissioners: I live in the East Lake area of Decatur, and have lived here for 4yrs after moving down from Connecticut. My husband and I foster dogs for Lifeline Animal Project and recently found ourselves fostering a puppy who was seized as part of a neglect case, along with 4 other puppies and 5 adult dogs. During these last 6mos of fostering this puppy, I have learned more about the court case system for dogs here in Dekalb County and am asking for your help addressing the issues I have observed throughout this time. I am sure you are aware that the DeKalb County shelter is severely overcrowded now, and has been for months. There are currently over 500 animals in the building, and about 100 of these dogs are actually court case dogs being held as "live evidence." Most of them have been in the system for almost a year and some even longer. Unfortunately, the Solicitor's office and the courts claim nothing can be done to move these cases forward faster and continue with the status quo. The Solicitor's office also seems unaware of options available to them and the dogs such as Motion to Dispose and Cost of Care. As my representatives I am asking you to work with the Solicitor's office and the courts to help resolve these cases in a timely manner with actual consideration of the dogs care and well-being, and not treated like evidence sitting on a shelf. These animals are being seized for a reason (neglect or cruelty), and then are held in basically prison indefinitely while the courts have no consideration to the victims - the dogs. It is also a severe waste of county resources and my tax dollars, and it puts a further strain on the shelters. The cost of care for these dogs is now the shelter's responsibility, and at even \$10 a day (which would barely cover food, let alone medical care) for the 100 dogs in the shelter for one month would be \$30,000. And there is no case that has taken less than a month. These are tax dollars that could be spent in so many other ways, and while I believe there are so many issues that need to be addressed around all of the dogs in the shelter system, spay and neuter laws, and the ordinances that allow owners to keep their dogs outside, I will focus my email today on the DeKalb County court system. Please work with the Solicitor's office to address the preparation they do for these cases to hopefully move these cases along, and reduce the strain on the community and shelter. Thank you for your time, and consideration.
- 4. Anna Oltmann, 2917 Whitby Drive Atlanta, GA 30340- Dear DeKalb Commissioners, I am a resident of Embry Hills and a regular volunteer at DeKalb County Animal Services. As you may know, there are currently over 500 dogs residing at the DeKalb shelter with over 80 of them being held on court hold. The average stay for a court case dog is over 6 months with some being held up to several years. Despite dedicated volunteers and hardworking staff, this puts a massive burden on limited shelter resources. I regularly attend many of their court proceedings in Magistrate Court. I have seen firsthand cases continually reset because owners simply do not show up to court. Often, the 6-month length of stay is not due to a delay in getting their court dates on the calendar, as we saw during the height of the COVID-19 pandemic, but rather simply because the defendants do not show up. Solicitor's staff and judges are indifferent and simply reset the case for two weeks. This cycle can go on and on for months. Holding animals for this length of time is unique to DeKalb County, and there is a

legal process in which the Solicitor's office can file a motion to dispose at any time to release the animals from this cycle. When owners do show, I have also seen the solicitor's office do a poor job preparing for cases. They often seem unaware of basic details of the case (including medical reports, field notes, and intake reports). Sometimes this is due to a lack of available collected evidence, but often it is due to the solicitor's office being unprepared (seemingly opening case files and reading them the day of) and unaware of local ordinances. Defendant's history of similar charges is rarely discussed. Potential witnesses like shelter volunteers and fosters who want to testify or speak during sentencing are never given opportunities despite reaching out to the solicitor's office. Serious charges like neglect/cruelty are amended to lesser charges to prevent harsher consequences for the defendant, which puts the victim back in the same position that led to the charges. Thus, the cycle of neglect and cruelty continues (as you know violence towards animals is strongly correlated to violence towards humans). As a concerned resident, I would like your help in supporting an improved and transparent process for addressing the cases. Thank you for your time and consideration. Sincerely,

- 5. Deb Hammacher, 3833 Gleneagles Ct. Tucker, GA 30084- Dear DeKalb Commissioners: As a DeKalb resident and taxpayer, I am concerned about the appalling handling of animal neglect and cruelty cases in our county. I am a volunteer for LifeLine Animal Project, so naturally I care about the animals involved as "live evidence." But animals aside, the waste of taxpayer resources is mind-boggling. Between the cost of care in the shelter and the court dates clogged with no shows, there is a huge impact on communities. I have attended court on multiple occasions. There appears to be no documented or accepted process whatsoever. In addition to this fundamental problem, there are three issues: 1. The lack of concern by most judges for the animals or the slots on the docket. Every time I've been to court, there are multiple no-show defendants. The judge simply resets the case for two to four weeks in the future. That's weeks more of the animals in limbo, confined to small cages. Other counties do not hold animals indefinitely as live evidence. They make their case with documentation, pictures and videos. 2. The shocking lack of preparation and competence of the solicitor's office. They are unprepared, appearing to first open the file that morning. They do not know the law. They do not know basic court procedures. They do not request evidence from the shelter, the ACOs, witnesses or foster parents. For example, I watched the senior ASG broker a plea deal that was not permissible under the statute, then fail to mention that the larger required fine could be paid with community service—and then the judge talked the defendant out of the plea deal. There is zero research done on the priors of the defendants, many of whom have long histories of neglect and cruelty charges. 3. The failure of animal control officers to properly document cases; failure to call in police as they should to get state charges filed; failure to provide information about a defendant's known history of animal abuse, neglect and cruelty; and failure to issue citations as they should. This may be a training issue. The DeKalb shelter is overcrowded as it is. Add to that dozens and dozens of animals in limbo as the incompetent animal court system drags on. Everybody points the finger at the others for cases dragging on or failing. This is a community problem—there is a well-documented link between animal cruelty and other crimes, including domestic violence—and a complete waste of taxpayer resources. This has been going on for years. There need to be tougher ordinances, consequences for no-shows, better enforcement of the ordinances we have, and a clear process for handling animal cases. Please help. Sincerely,
- 6. Hadley Recor, 4169 Triple Creek Court, Brookhaven, Georgia 30319- Dear DeKalb Commissioners, My name is Hadley Recor and I live at 4169 Triple Creek Court, Brookhaven, Georgia 30319. I have volunteered at the DeKalb County Lifeline Shelter for over five years. As you are aware, the shelter has had to shut down

the intake process for the second time this year due to overcrowding. What you may not be aware of, is part of the problem causing the overcrowding is the backlog of court cases. Dogs being held due to court cases account for about a third of the dogs in the shelter. Court case dogs often come in as puppies and are very adoptable, but by the time the court case is resolved they have reached adulthood and have socialization issues from being in the shelter for so long, making them difficult to adopt. Court case dogs can be at the shelter for literally years. They rarely get walked (an average once or twice a month) and have very little human or dog contact. I myself have witnessed the heartbreaking scenario of a dog literally going insane from being in a kennel for over two years. Unfortunately he could not take the stress of being in the shelter for so long and became a danger to himself and others. He was put down as soon as his court case was resolved. I have also witnessed puppies on court holds get sick and die because they have little immunity to the diseases that are present in the shelter. The frustrating thing is there is absolutely no reason these dogs need to be on court hold for so long. They are sapping up limited space and resources because the DeKalb County Solicitor's Office and Judges are completely indifferent to the impact on the dogs of having to stay in the shelter. Cases are reset multiple times when the owner doesn't show up. The solicitor's are often poorly prepared and unaware of local ordinances. They refuse to file for the dog's release even though the dogs are not needed for evidence - photos and videos are more than sufficient. There is a simple solution for this issue - the solicitor's office can file a motion to dispose, and the dogs would be released from their court hold. I am appalled at the way the system shows a complete lack of compassion for the animals we are supposed to protect. I am asking for your help in getting this issue addressed by the solicitor's office and the judges in Dekalb County. If any of you would like to visit the shelter to observe the issues for yourselves, I would be happy to meet you at the shelter and give you a tour. Thank you for your time.

- 7. Sarah Zeeman, 2740 Grove Street Ne Brookhaven, GA 30319- Hello Commissioners, Thank you in advance for allowing me the opportunity to provide my public comment today. My name is Sarah Zeeman; I have been a resident of DeKalb County for almost 40 years. In addition to my day job as a Digital Media Professional, I have rescued over a dozen dogs throughout my lifetime. I am currently fostering two live evidence animal cruelty case dogs (victims) who are members of a group of 6 dogs seized into the state's custody in August 2019. These seized dogs have been in the court system for over 3 and half years, roughly ~1140 days. A general guesstimate for the cost of care for the 6 dogs at ~\$10 a day per dog comes to almost \$70,000+ which is unknowingly being paid for by DeKalb county taxpayers. The shelters are overcrowded, loud, emotionally damaging, and could be compared to the equivalent of a doggie jail. Dogs do not have long life spans, and when learning about another DeKalb court case where the dog has been in the shelter since 2018 and is heading past its 4yr+ anniversary! At this rate, this dog may not live to see the day he's released from the court's custody. The court case animals (victims) have already survived an array of complex circumstances only to be put into an emotionally unsettling environment for an average of more than 6 months, with their shelter sentences progressing into years paid for by the DeKalb county taxpayers. What additional options can be explored to proactively expedite animal court cases to move them through the system before their shelter sentences have yearly and multiple-year anniversaries? Could DeKalb initiate these proactive options to help the court case animals (victims) and the taxpayers ultimately footing the bill? Thank you so much for your time and consideration.
- 8. Claude McLane (No Address)- Dear DeKalb Commissioners, I'm a semi-retired contractor and 60 year resident of DeKalb County. I volunteer 12 to 15 hours a week walking dogs and helping with maintenace on

the 5 year old DeKalb shelter. My wife and I also foster dogs through DeKalb, most recently temporarily fostering 2 different court case dogs, both of which had been at the shelter for over 6 months. We learned a lot about the judicial process through their neglect cases. Today, I'm asking you to help fix some of the processes so that the victims of animal cruelty and neglect are not paying the price for the actions of their irresponsible owners. When I volunteer I pass court case dogs in the isolation kennels, a large majority of whom have been there over 6 months, and some in the system for multiple years. Approximately 15-20% of the dogs in the overcrowded shelter are neglect court cases, dogs that are not legally adoptable and often become even less adoptable due to the negative impact on temperament and behavior which often results from long term stay at the shelter. There seems to be a callus indifference to the plight of these animals and the burden on the county by the Solicitor's office and Judges. * Cases are reset multiple times because owners don't show up to court and the animals remain in the system. * The Solicitor's office consistently does a poor job preparing for cases. They rarely call witnesses or even have a witness list and come to court without evidence like medical reports, field notes and intake notes. * The Solicitor's office is often seemingly unaware of local ordinances and state statutes. * All of which results in weak prosecution and unnecessary cost to the county. Why are we not taking these cases seriously? It is also well documented that there is a link between animal cruelty and violence towards humans. Questions to be answered: * I'm told that keeping court case animals as live evidence for this long is unique to DeKalb. Why? * Do we really need to keep the animals in the system as live evidence for neglect and cruelty cases? Why not instead use pictures, video, witnesses, and records to prosecute a case. * Are we being reasonable with county's resources to continually reset these cases when owners don't show up multiple times? * What are the court procedures if any when a defendant doesn't show up and What is preventing the Solicitor from filing a motion to dispose for long term court animals? Thank you for considering this issue as a priority. I believe with not much effort we can achieve a win-win solution that will serve all citizens of DeKalb.

9. Susanne Blam, 191 Locust Street NE Atlanta, GA 30317- Dear DeKalb Commissioners, I live in Kirkwood and am a lifelong DeKalb County resident. I recently became a volunteer for Lifeline and foster a shelter dog. In this volunteer and fostering role, I have become painfully aware of the horrible overcrowding at the county animal shelter and more specifically, the unique problem of court case animals. Some of these problems can be prevented and as leaders of the county, I am asking you to please address them. I'm sure you are aware that your county animal shelter is severely overcrowded. There are over 500 animals in the building. Close to a hundred of these animals are held needlessly as "live evidence." Most of them have been in the system for almost a year, some for many years. Their cases keep getting reset because owners do not show up. Unfortunately, the Solicitor's office and the courts claim nothing can be done and continue with the status quo. These animals are suffering. They come from abuse and neglect situations and then are held in confinement by the system for an indefinite period. The longer the animals stay in the shelter, the more they deteriorate. As county representatives I am begging you to work with the Solicitor's office and the courts to solve this problem and resolve these cases. What are the procedures of the Solicitor's office? Is it necessary to keep the animal as live evidence into perpetuity while the case keeps getting reset? Are there no other options that would ensure a strong prosecution? Why are owners not held accountable for not showing up in court? And why are the animals continuously forced to pay the price for a flawed process? I would like to reiterate that it is inhumane for the county to keep these animals so long. It is also a severe waste of county resources and my tax dollars, and it puts a further strain on the shelters. The Board of Commissioners approves the budget for the Solicitor's office and the courts, so it is well within your responsibility to see how this budget is utilized. Again, I beg of

you to please work with the Solicitors office and courts to address these problems as soon as possible. Every day delayed; more animals suffer! Thank you for your time and consideration. Sincerely,
