C. COMMENTS FROM THE PUBLIC

The purpose of public comment is to allow the public to voice county-related requests, concerns or opinions during the Commission meeting. Speakers will only have the opportunity for one public comment per meeting. Each speaker must complete a speaker card and present it to the clerk before the beginning of the public comment portion of the meeting. Cards turned in to the clerk from the time the general meeting is convened (generally 9 A.M.) and by the beginning of public comment portion generally following presentations on the agenda. The clerk will accept cards on a first-come, first-served basis. Prior to the clerk’s call for public comment, speakers who are residents of DeKalb County shall be allowed to speak before residents of other

counties are allowed to speak. Once the public comment portion of the meeting begins, speaker cards will no longer be accepted. Speakers will be allowed to speak for three minutes each and public comment shall not exceed 30 minutes in length. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to yield the podium. Those who submitted speaker cards but did not speak because of the time allotment will be allowed to speak first at the next regularly scheduled Commission meeting without regard to residence. Speakers should always talk directly into the microphone and begin by stating their name, full address and the name of any organization they represent. Abusive, profane or derogatory language, holding up signs, clapping, yelling, standing or laying in the aisles to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing in place will be permitted to show support for or opposition to a speaker's position.

Public Comment Emails- October 11, 2022

1. Heidi Glick, 2753 Zoar Ave Decatur, GA 30030- To Dekalb County Board of Commissioners, I am writing to urge you to oppose the transfer of Lanier Gardens and the accompanying greenspace along Arcadia Ave. from Dekalb County to Avondale Estates. I live next to this greenspace in Decatur Terrace. We use this park for dog walking and enjoy it as a buffer from the traffic at Sam's Crossing. Decatur Terrace lies between the City of Decatur and the City of Avondale Estates. We were once known as 'no man's land' however we are a close-knit neighborhood. We are unincorporated but we know that annexation may come up again in the future because we are such a narrow strip of land between the two cities. We urge you to oppose the transfer of Lanier Gardens and the two additional parcels of greenspace along Arcadia Ave. because it would limit our future annexation options. Decatur Terrace only learned about the park transfer agreement on 10/4 when we read about it in Decaturish. We are disappointed that Avondale and Dekalb have not included Decatur Terrace in the planning for this park to understand what this new city boundary would mean for our neighborhood. Please take this into account as you consider your vote on this agreement. Thank you,

2. Gracia Zabinski, 1853 Audubon Drive Atlanta , Ga 30329- We are residents on Audubon Drive for over 35 plus years and very concerned and opposed to the PATH use in the neighborhood. Project BOCC 2022-2081. The following are concerns and will impact our street with families with children , elderly, pets owners ,all residents are; Safety Security Sanitation Traffic Pollution Thank you

3. Ashlie Shepard, 1892 Audubon Dr NE, Atlanta, GA 30329- We strongly object to any approval of funding related to BOC 2022-2281. As residents on Audubon Drive NE, we have not been adequately involved or updated on the construction plans of the PATH and the direct impact to our dead-end street. On June 8, 2022, we provided a signed petition of Audubon Drive NE residents, where 21 homes of the 25 total homes on the dead-end street (84%) opposed BOC 2022-1153, stating we believe other adequate alternatives should be considered. All Dekalb County Commissioners and the PATH were in receipt of this signed petition and no response was received addressing any of our stated concerns. We do not desire nor need Audubon Drive NE to be part of Dekalb County and the PATH's plan, especially when we have yet to receive any response to our concerns and there has been absolutely no engagement with our impacted residents. Dekalb County has an obligation to the community. We deserve a seat at the table to discuss and debate all options and we most certainly deserve to be involved to provide input on the decisions that directly impact us and our homes. We believe the project would negatively impact the sense of community we currently share on our street and it would significantly impact the current calm on our dead-end street (no-through traffic). Not to mention, there are plenty of safety and security concerns. Please note our complete opposition to BOC 2022-2281. Thank you for your consideration.

4. Lee Howard, 1887 Audubon Drive. NE Atlanta Ga 30329- I'm writing to oppose BOC2022-2281, Segment #2 Briarcliff Connector, for the following reasons: • The 28 property owners on Audubon have never been included in planning with PATH or DeKalb County. • In September the DBOC voted to approve the trails master plan, again without input from the Briarcliff Heights homeowners, and without any Commissioner making a public comment. There were however several public comments supporting the legislation, some without listing their address as required by the commission. Who are these people, where do they live and what do they have to gain from this project? • The commission has moved very quickly, again without public input to allocate over \$1M to fund construction and property acquisition. Why the hurry? • This rush to approve the project with no input from the affected homeowners has created more questions than answers. I request that

this matter be tabled until February 2023 or until the newly elected Commission has been sworn into office. This will allow the commissioners that will represent DeKalb going forward to hear from their constituents, and make better informed decisions. This will also remove any doubt that lame duck, outgoing commissioners are having undue influence on projects that those that they represent do not want and will be adverse effected by their implementation. • Audubon Drive is a very steep, hilly street. It doesn't lend itself to pedestrian or bicycle traffic. Our residents include families with newborn and young children and retirees. We do not need cyclists speeding up and down our street. • PATH has stated that Segment #2 is part of a larger project to connect neighborhoods to CHOA. Why? If anyone needs to take someone to the hospital or to visit a patient, they wouldn't ride a bicycle or walk they would simply drive a car from Audubon Drive, Beacon Hill, Belle Isle or Knob Hill. Thank you for your time and consideration.

5. Anders Olsson & Valerie Smith, 1907 Audubon Dr NE, Atlanta, GA 30329- Thank you for taking the time to read our comment. We would like to state our opposition to BOC 2022-2281 for the following reasons: • As residents of Audubon Dr NE, there has been no communication from the Board of Commissioners, PATH, or any other institution regarding the installation of the new PATH project. Additionally, inquiries submitted by my neighbors were not returned. The rapid pace of advancing this project indicates that those responsible are not interested in the concerns or desires of the local residences. • PATH stated that there would be two public meetings on the development of the project. To our knowledge, only one was held. At this meeting, the residents of Audubon Drive were told that our street was not included in that meeting by multiple PATH, KAIZEN Collaborative, and County Commissioners present during the meeting. • Audubon Dr NE would see no benefit from the PATH project. In fact, one could argue that this project could result in more risk than benefit, as those planning the project did not coordinate with residents to hear their concerns, with the primary concern being the safety of crossing a state route (Clairmont Rd). Involving the residents in more decisions is an obligation of Dekalb county and may result in a resolution that saves the county time and taxpayer dollars while still meeting the goals of the PATH project. Again, we appreciate your time and consideration.

6. Caren Feingold, 1657 Bridgeport Drive NE Atlanta, GA 30329- Dear Board of Commissioners, I am an avid walker and user of Path Foundation paths. Imagine my surprise when I learned that there is a proposed path through my own Briarcliff Heights neighborhood and, that if it hadn't been for a couple of neighbors, I would have had no idea of the existence of this proposal. This is disappointing and alarming. Where is the transparency? Where is the community buy-in? In this time of distrust in our governmental bodies, what a missed opportunity! It makes no sense to provide an amenity that benefits the end-users but disregards the impact on those who are closest to the path. I respectfully request that you pause further movement on this proposed path until you create a robust vehicle for neighborhood education and true neighborhood input.

7. Barbara Emmanuel, 776 Hillmont Avenue Decatur, GA 30030- To esteemed members of Dekalb Commission: I am writing to ask that any decision on granting the land called Lanier Gardens to City of Avondale Estates be postponed until the residents of Decatur Terrace have had a chance to publicly voice our concerns. This opportunity has not yet been given, and although our neighborhood is adjacent to Lanier Gardens, we were not made aware of this proposal until an article was written fir Decaturish. One primary concern is if our neighborhood is completely bounded along Arcadia Avenue by Avondale, it will severely limit our future opportunities regarding annexation. We are happily unincorporated at this time, but should we be required in the future to be annexed, we would like to have the option of City of Decatur or City of Avondale

Estates. My understanding is that if there is no contiguous connection in the future to City of Decatur, our only option would be Avondale Estates. We are also concerned that this land transfer puts us one step closer to being an island, which I understand is not allowed by state law. Third, we are dismayed that our opinions were not sought out in any way in this process, which is similar to past dealings with Avondale Estates. This is very concerning as our neighborhood will bear the impact of this transfer. Thank you for considering delaying this decision. Sincerely,

8. Michael M Beeson, 1844 Audubon Dr NE Atlanta GA 30329- Sirs, Thank you for your time. I want to express that I am NOT in favor of BOC 2022-2281. Additionally, I have found the lines of communication challenging and have not felt included. I would love to know the details of the PATH construction as well as notice of public meetings. I have resided on Audubon Drive NE for twenty eight years. My decision to purchase this home was strongly influenced by the quiet of our little street with resident only traffic. Again thank you for your time and consideration. Commissioners - We are Ann Kathryn Hudson and Suzanne E. Phillips, owners of 1715 Beacon Blvd since 1988. And yes, we are senior citizens. And, taxpaying residents of DeKalb County for over 40 years! We are opposed to BOC 2022-2281. First, thank you for allowing us to comment at this meeting regarding funding for the South Fork Peachtree Creek Trail. We are against this project and the funding for it. We ask that you listen to neighborhood input from Briarcliff Heights and those on Audubon Drive. At the March 10, 2022 planning meeting we were told you would not put a PATH where people did not want it. We and our neighbors on Audubon and in Briarcliff Heights do not want it. Audubon Drive is dangerous for pedestrians because the sun blinds drivers on this east/west street. Crossing Clairmont at Audubon is so dangerous the DOT is planning right turn only ingress and egress. If it's not safe for cars, it's certainly not safe for pedestrians or bikers. Ask those who live here! It would be better to run the PATH along Briarcliff Road. It would connect to the new development going on at the Briarcliff/Clairmont intersection. You could easily bike or walk to the Post Office, restaurants etc. It could run from Cliff Valley to Fisher Trail, making the same connection but not going where it is not wanted. Those who live in Briarcliff Heights can easily get to Briarcliff. In the 1/3/22 PATH Agreement with DeKalb County we were mentioned by name as owners of property needed for this project. It also states at the very beginning that DeKalb County will be responsible for "Coordination with property owners for permission to access the project's corridor for surveying, environmental delineations, and all design/engineering site walks." And yet, surveyors trespassed on our property a number of times. They damaged our fence when they crossed over it to tag trees on our property. Not only was there no permission, but also no notification and no explanation! We have a constitutional right and DeKalb County has a specific contractual obligation to co-ordinate with us for access to our private property for this project. We were identified as owners in January and yet our first notice was a rather vague notice about attaching our driveway to a new sidewalk in October. Why not an attachment explaining the grand plan for building a PATH through our property?? We want to be good citizens. We want to be informed citizens. We want input when our neighborhood is being affected. We expect our county government and our commissioners to be pro-active in advising individuals and neighborhoods about plans that specifically involve them. Signs, letters, meetings. We are against the part of the project that cuts through Briarcliff Heights. We do not consent to a taking of our property or conceding any of our rights as property owners in DeKalb County. We ask you to not fund this project. Thank you for this opportunity to comment, we wish we had known about it earlier in the process.

9. Joan Karpeles, 1659 Belle Isle Circle Atlanta GA 30329- To the Board of Commissioners: This email is

being sent to you in regards to the funding for Segment #2 of the South Peachtree Creek Trail Expansion. We respectfully request that you not approve the funding because the neighborhood, specifically Beacon Hill and Belle Isle Circle residents, have received no detailed information about this expansion. We were never notified of prior meetings and all information to date has been provided by word of mouth. I personally sent an email and left a couple of voicemails to the PATH Foundation requesting information but never received a response. The South Peachtree Creek Trail, Northern Study Area prepared by PATH Foundation dated August 30, 2022, suggests that there was community engagement and concerns were addressed, however, many neighbors in the Briarcliff Heights area were not notified of these community meetings. The only concerns noted in the study for the Briarcliff Heights neighborhood was that "some property owners on Audubon Drive were opposed for the cul-de-sac becoming a main bike/ped route." Many of the property owners I talked with on Beacon Hill and Belle Isle Circle were also opposed to our streets becoming a main bike/ped route. My hope is that the Commissioners vote not to approve the funding unless and until there is more community engagement and our concerns are addressed. Respectfully,

10. Robin Reese, 1908 Audubon Dr NE Atlanta, GA 30329- To Whom It May Concern: I am writing to express my opposition to BOC 2022-2281. We were told at the first of the 2 public meetings that Audubon Drive was not included in that meeting by multiple PATH, KAIZEN Collaborative, and current County Commissioners present at that meeting. We have minimal traffic on our dead-end street and would see no benefit from the project. 11. Uri Wurtzel, 2753 Zoar Ave- Hello, As a resident of the Decatur Terrace neighborhood, I am concerned that Avondale Estates is encircling our small but tight-knit community and therefore eliminating future options for inclusion in other municipalities. And nobody informed us of this effort, or asked for our opinion or concerns. It feels like a hostile takeover, not a neighborly proposal. I think this move needs to be rejected, or at the least shelved until its consequences for all affected can be hashed out. Thanks for your consideration,

12. Marina P. Costarides, 1837 Audubon Drive, NE Atlanta, GA 30329- Please be advised that I am strongly OPPOSED to BOC 2022-2281. I do not feel that we have been adequately included and involved in plans with the PATH for Audubon Drive. At a meeting in May, we were told that members of the PATH came to Audubon and knocked on our doors to discuss plans. None of us recall such an occurrence. It would have been more helpful if we received a letter from PATH and Dekalb County Commissioners regarding plans on the PATH for Audubon Drive, giving us time to comment. We that reside on Audubon Drive, have chosen to live in our neighborhood as it is on a dead end street and allows for minimal traffic. We see no benefit in having a PATH in our neighborhood and in our "front yards". I have walked the Beltline, The PATH at Murphy Candler Park in Dunwoody and the PATH at Mason Woods Park. I did not see any PATHs in peoples' front yards. Being a tax payer in a "residential" area, on a dead end street, should be reason enough to honor our concerns. We expect our Dekalb County Commissioners to vote on what their constituents need. Our major

concerns are: Safety: A very large number of individuals will be coming down the PATH in our peaceful neighborhood, roller skating, on scooters and skate boards, bicycling, walking and running. When backing out of our driveways, we would hope especially those on bikes, roller skates or on skate boards would have ample time to stop; otherwise, there could be some MAJOR accidents. If individuals with undesirable motives choose to walk down our street, the PATH would encourage vandalism on our properties. Property Value: Our property value decreasing is another huge concern. Aesthetically, the PATH would not be appealing in our front yards. Many potential buyers may not want a PATH in front of their homes. For many of us, our homes are our largest investment. We have voted on our Dekalb County Commissioners to act on our behalf and strongly feel that they should do so. We were not adequately consulted and feel that we need to be heard. Please seriously consider re routing the PATH, so that it will NOT be on Audubon Drive in our front yards. Your time, support and attention to this matter is greatly appreciated.

13. Joan Karpeles, 1659 Belle Isle Circle, Atlanta 30329- To the Board of Commissioners: This email is being sent to you in regards to the funding for Segment #2 of the South Peachtree Creek Trail Expansion. Margaret and Zdzislaw (Jacob) Zabinski, 1863 Audubon Dr. Atlanta Ga 30329- As residents of Audubon drive since 1976, we strongly oppose PATH project BOC 2022-2281. - We have not been adequately involved in how the PATH will be constructed on our street and our inquiries for further information were not returned. - PATH's SOW stated 2 public meetings would be held on this, and only 1 was held. We were told at the first of the 2 public meetings that Audubon Drive was not included in that meeting by multiple PATH, KAIZEN Collaborative, and current County Commissioners present at that meeting. - We have minimal traffic on our dead-end street and would see no benefit from the project. As a result, we believe DeKalb has an obligation to minimize the impact of this alignment on our community and involve us more in decisions. -Steep hill on Audubon is going to cause a lot of incidents between residents and PATH users-skateboarders, bike riders, etc. Thank you for your time and consideration.

15. Tom Minko, 1836 Audubon Dr. NE Atlanta, GA 30329- Reading through tons of documentation from many different places, it appears that DeKalb Commissioners have partnered with corporatizations and Sagamore Hills residents rather than supporting all constituent. There appears to already be an end goal and the Path Foundation is twisting everything, purposely not communicating or requesting input from streets they know

will not be in favor of the Greenway and Segment #2 Briarcliff Heights Connector. I think the DeKalb Commissioners are not receiving all the information. If the DeKalb Commissioner want to see how residents of the impacted streets feel and think they should go take a look on NextDoor, that will provide them with an unbiased opinion and a good mix of people. If DeKalb Commissioners truly support all resident's surrounding the purposed Segment 2 Briarcliff Heights Connector, they will vote NO to BOC 2022-2143. 16. Brad Parker, 1892 Audubon Dr NE, Atlanta, GA 30329- We strongly oppose BOC 2022-2281. We live on Audubon Drive NE where multiple residents have reached out on multiple occasions to Dekalb County Commissioners and PATH with our many concerns with the set forth plans that will substantially and negatively impact our street. As a street, we also signed a petition that was provided to our Commissioners and PATH and it's beyond unfortunate we have received no response. We attended public meetings on March 10, 2022 and May 11, 2022, where we were given conflicting information about the plans for Audubon Drive NE. We were told Audubon Drive NE was not included in the study by current County Commissioners present at the meetings. We submitted our questions, concerns and responses to the Dekalb County Peachtree Creek Trail study survey and once again received no follow-up or response. We have diligently continued to check Legistar due to the lack of response from our Commissioners and came across the shockingly approved 139 page document "detailing the plans" of Dekalb County and PATH. While there is a lengthy approved document, a lack of true detail and transparency exists specifically within Segment 2. The true impact and construction plans for Audubon Drive NE are not clear and we have not been adequately involved with how the path will be constructed on our street. Our currently seated Commissioners appear to be deviously shoving this project through behind closed doors with no regard for their elected responsibility to communicate, serve and act upon the community's wishes. Please note our complete opposition to BOC 2022-2281. Thank you for your time and consideration.

17. Alex & Andrea Kennedy, 1915 Audubon Dr NE, Atlanta, GA 30329- Commissioners, thank you for your consideration in this matter. Audubon Drive NE is a special street. It is a quiet and close knit dead-end street where all of the neighbors know and watchout for each other. Audubon is a very diverse and serene street; the perfect place where my wife and I want to raise our newborn son. We have zero pedestrian and minimal vehicular traffic making it a safe place for children to play in the front yard or ride bicycles up to the dead-end and back. I purchased my home here many years ago due to the fact it was a quiet dead-end street which seemed to be in a protective bubble. This project will pierce that bubble and completely ruin the character and quality of the street. The residents of this street, myself included, have been disappointed that it seems many of our suggestions of alternatives as well as our concerns have been disregarded. We have not been adequately involved in how the PATH will be constructed on our street and our inquiries for further information were not returned. PATH's SOW stated 2 public meetings would be held on this, and only 1 was held which dealt with Audubon Drive NE. I implore you to consider how drastically this will alter the character of the street and negatively affect the burgeoning families who live here.

18. Elaine Sha (No address)- I live at the end of Audubon Drive bordering the turnaround at the dead end. There is a utility pole on the other side of the street that narrows the turn around significantly and most of the DeKalb county trucks have to make 7-9 point turns just to get turned around there. My concerns are now if a

path is located here there is a space limitation - there will be others parking and clogging up that turnaround even more. I know I will be losing at least a 6 foot section of my front lawn but people (landscapers in DeKalb county service trucks) have been driving on/damaging my lawn for years just to get their vehicles turned around. My second concern is construction people in the area without any regard for noise/littering in a general lack of consideration to homeowners in the area.... Would love to hear how people plan to address these concerns?

19. Eubert Querubin, 785 Dalerose Avenue Decatur, GA 30030- To Dekalb County Board of Commissioners, I am asking you to postpone, not approve, or vote against giving Lanier Gardens and the greenspace on Arcadia Avenue to the City of Avondale Estates. As a Dekalb County resident, living in Decatur Terrace, I strongly believe we benefit more than Avondale Estates claims to have on that land as this is our day-to-day walking and bike routes to and from the adjacent cities. We ask that you keep this space within your borders as we are loyal tax payers and prefer it to remain unincorporated as does our neighborhood. In the recent decade, Avondale Estates has not extended the courtesy of sharing their interest with our neighborhood on the adjacent properties including ours. Just years ago, we worked with our state representatives to block Avondale Estates annexation proposal, which the city claimed we were in support of. In turn, though we prefer to stay unincorporated, our preference was to be annexed by the City of Decatur if having to be forced into it. Hence, we received signatures of more than 80% of our neighbors to petition against Avondale Estates, and separately petition for the City of Decatur should we be forced out of Dekalb County. As Avondale Estates did not, again, give us any notice of their intent and did not act in good faith to notify us of their plans. We would have only known of this because of an article posted by a third party (i.e., Decaturish). Avondale Estates continues to add fuel to the fire of an already strained relationship with our neighborhood. These acts will continue to cause opposition should we proceed with action if you give Lanier gardens and the greenspace over to them. Thank you for letting our voices be heard. Sincerely,

I was dismayed to learn in recent days of the proposed land transfer to Avondale Estates. No public comment period for this apparent land grab was advertised - at least adequately -

nor were residents in the affected area contacted directly. Given Avondale Estates' history of attempting to annex Decatur Terrace, this is the obvious next step to achieve their goal of obtaining Decatur Terrace and surrounding unincorporated neighborhoods who have generally resisted incorporation by Avondale Estates. I recall two attempts in the last ~5 years, and from the perspective of the majority of Decatur Terrace residents, Avondale Estates' process was opaque; neither attempt involved direct input of the neighborhood, and to us, the decision-makers were following an undemocratic process behind closed doors. I implore the commissioners to treat this process in a manner that is fair to all those involved, including Decatur Terrace residents, and to table the matter for further discussion. I personally am against the land transfer and I do not believe making a final decision today would be consistent with a fair, transparent process in which the public, especially affected parties, has had adequate time to voice any and all concerns. If the transfer is approved, Avondale Estates would choke out Decatur Terrace making any future incorporation by Decatur highly unlikely. The next logical step would then be annexation by Avondale Estates, which has been repeatedly opposed by the neighborhood. Furthermore, by circumscribing our neighborhood, Avondale Estates governmental vehicles are sure to travel through our small, narrow roads that lack sidewalks more frequently creating a hazard and risk to pedestrians and children at play. Lastly, it is unclear how Avondale Estates intends to use the parcels in question. I have read they seek to create a "gateway" to Avondale Estates, in which case, why can't a sign suffice, perhaps on the Lanier Gardens corner? Why must they also have the parcels to the south if not to suffocate Decatur Terrace with the ultimate goal of annexing the neighborhood? Please do not enable Avondale Estates' expansionist goals without a full period of due diligence in which Decatur Terrace and other affected neighborhoods may have the chance to review the impact of the land transfer and explore legal routes to opposition, should the majority of residents choose.

Why is there only one emergency shelter in DeKalb County--Hagar's House, for families? Nothing for individuals. Our church hosted an overnight emergency warming center in our Fellowship Hall a couple of years ago when we learned that our county had NO place for unhoused people to go when the temperature was freezing. Last winter, the county opened fire stations, but it was haphazard--they were hard for unhoused people to get to, and there was little to no hospitality offered. Ever since the tri-county arrangement with HUD dissolved, DeKalb County has had NO PLAN for how to compassionately care for our unhoused neighbors. We have NO PLAN for eviction prevention and for preserving affordable housing. We were "saved" by ARP funds--but those are gone now. This is an incredibly compassionate community--the faith communities, great nonprofits, and concerned neighbors are ready to help. But without basic organization and commitment from the Community Development department, we will continue to muddle along, and our most vulnerable neighbors will be the ones who continue to suffer.

Because of the severity of the Urethral blockage, it was likely that he would have died in utero, but there was no guarantee that this would happen before he reached 29-weeks gestation, when pain receptors are large thought to begin to register pain. In the off chance that he should have survived, we were told by the head of fetal medicine at Children's Hospital of Atlanta that he would not have been deemed a old candidate for the life-prolonging surgery he would require. This means he would be left to suffocate in our arms sometime in the first 24 hours after birth. Because these diagnoses were finalized around 21 weeks and 2 days and because Georgia's law then allowed abortion care up to 22 weeks, we were forced to make the most terrible and significant decisions of our lives in less than 24 hours. But at least we had the right to make that decision, the best choice among a field of truly terrible options. Our decision was an act of love - for our living daughter, for ourselves, and for our sweet Rowan Harris Campbell. Our decision also represented an important healthcare decision for me and for our unborn son. Healthcare is a fundamental right and no one deserves to be criminalized for exercising a fundamental right. In October 2019, my daughter made the heart-wrenching decision to end the suffering of her beloved son before it had a chance to begin. At the 20-week ultrasound, he was diagnosed with a Posterior Urethral Valve as well as Atrial Ventricular Septal Defect and Hypoplastic Left Heart Syndrome. Because of the severity of the Urethral blockage, it was likely that he would have died in utero, but there was no guarantee that this would happen before he reached 29-weeks gestation, when pain receptors are large thought to begin to register pain. In the off chance that he should have survived, we were told by the head of fetal medicine at Children's Hospital of Atlanta that he would not have been deemed a viable candidate for the life-prolonging surgery he would require. This means he would have been left to suffocate in his parents' arms sometime in the first 24 hours after birth. Because these diagnoses were finalized around 21 weeks and 2 days and because Georgia's law then allowed abortion care up to 22 weeks, they were forced to make the most terrible and significant decisions of their lives in less than 24 hours. But at least they had the right to make that decision, the best choice among a field of truly terrible options. Their decision was an act of love. Their decision also represented an important healthcare decision for my daughter and for her unborn son. Healthcare is a fundamental right and no one deserves to be criminalized for exercising a fundamental right. As one of the largest counties in Georgia, DeKalb has the opportunity to play a pivotal role in ensuring that Georgians have access to the full spectrum of reproductive health services, including abortion care.
