Task 1 – FOCUS AREAS LAND ANALYSIS AND VCC OPPORTUNITY MAPS (Months 1-2)

Deliverable: Technical memo with maps updating parcel analysis, refining focus area locations and identifying potential sites for conservation villages.

- Meetings: Up to three (3) virtual meetings with Commissioners or their staff. 1-3 commissioners or staff per meeting.
- Review/insure VCC theme consistency
- Develop focus area Mapping criteria

- Develop 5 (five) focus area maps that indicate potential sites for village conservation communities (one per traditional/suburban, two each for suburban pocket and rural pocket areas)

Refine policy considerations from Phase I including draft "by right" conservation village planned development (CVPD) and "conservation hamlet planned development" (CHPD) zoning for residential and commercial/mix use applications

Develop an initial educational strategy (with partners like the Ga Conservancy) to be used reach out to neighborhoods, citizen & organization advocates and civic organizations in general to explain the conservation/village community development tools and pro-active opportunities to initiate VCC's. <u>Village Habitat Design</u> \$7500?

- Connect with key partners and identify their potential roles going forward
- Develop an outline educational strategy and resources in the form of a narrative for future outreach to commissioners, neighborhoods, etc.
