A RESOLUTION OF THE BOARD OF COMMISSIONERS OF DEKALB COUNTY, GEORGIA AUTHORIZING THE PREPARATION AND DISTRIBUTION OF A REQUEST FOR PROPOSALS FOR THE SOLICITATION OF OFFERS FOR THE PURCHASE OF DEKALB COUNTY, GEORGIA TAX ANTICIPATION NOTES; AND RELATED MATTERS.

WHEREAS, the Board of Commissioners of DeKalb County, Georgia and the Chief Executive Officer of DeKalb County, Georgia (the "Governing Body") are charged with the duties of contracting debts and managing the affairs of DeKalb County, Georgia (the "County"); and

WHEREAS, the Governing Body has determined that it is in the best interest of the County to obtain a temporary loan in anticipation of the receipt of taxes levied or to be levied for the General Fund of the County for calendar year 2023; and

WHEREAS, the County is authorized by Article IX, Section V, Paragraph V of the Georgia Constitution of 1983 and Section 36-80-2 of the Official Code of Georgia Annotated, as amended and supplemented, to obtain a temporary loan to pay current expenses during any calendar year and to evidence such loan by issuing tax anticipation notes in anticipation of the receipt of revenues from taxes levied or to be levied for the General Fund for expenses payable in such calendar year; and

WHEREAS, the County is considering issuing such tax anticipation notes in an aggregate principal amount not to exceed \$[80,000,000] (the "Notes"); and

WHEREAS, in connection with the offering of the Notes, the County, with assistance from its municipal advisor, PFM Financial Advisors LLC, will prepare and distribution a request for proposals for the solicitation of offers from financial institutions for the purchase of the Notes (the "**Request for Proposals**"); and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DEKALB COUNTY, GEORGIA, as follows:

Section 1. <u>Authorization of Preparation and Distribution of Request for Proposals</u>. The preparation and distribution of the Request for Proposals for the solicitation of offers from financial institutions for the purchase of the Notes are hereby authorized; *provided that* any such prospective purchaser of the Notes shall be an institutional "accredited investor" within the meaning of Rule 501(a)(1), (2), (3) or (7) under the Securities Act of 1933, as amended. The Request for Proposals will be in the form to be approved by the Chief Financial Officer of the County, and the distribution of the Request for Proposals shall be conclusive evidence of any such approval.

Section 2. <u>Approval and Ratification of Certain Documents and Actions</u>. The actions of the Chief Financial Officer of the County and the County's municipal advisor, PFM Financial Advisors LLC, in causing information with respect to the County and the Notes to be prepared and distributed to potential purchasers of the Notes, including the preparation, use and circulation of the Request for Proposals, are hereby approved, ratified and confirmed.

Section 3. <u>General Authority</u>. From and after the date of adoption of this Resolution, the Board of Commissioners and the officers and agents of the County are hereby authorized to do all such acts and things, and to execute and deliver all such documents, certificates or agreements as may be necessary or desirable in connection with the offering of the Notes. All actions of the Board of Commissioners, officers or agents of the County taken in connection therewith prior to the date hereof are hereby ratified and confirmed.

Section 4. <u>Effective Date</u>. This Resolution will be in full force and effect immediately upon its adoption and any and all resolutions or parts of resolutions in conflict with this Resolution will be and the same are, to the extent of such conflict, hereby repealed.
