Move areas of the City of Chamblee from Ashford Park Elem (AB) to Chamblee (CE).

Move areas of the City of Atlanta from Terry Mill (TA) to East Lake (EA).

Move areas of the City of Atlanta from Fernbank (FB) to Lin-Mary Lin Elem (LE). Move areas of the 84<sup>th</sup> House District from Snapfinger Road S (SS) to Browns Mill Elem (BJ).

Move areas of the 42<sup>nd</sup> Senate District from Brookhaven (BI) to Briarwood (BE).

Move areas of the 88<sup>th</sup> House District from Marbut Elem (MC) to Redan Road (RK).

Move areas of the City of Tucker from Stone Mill Elem (SJ) to Stone Mountain Middle (SI).

Separate unincorporated areas from the City of Tucker in Briarlake (BD), Midvale Road (MW), and Montreal (MK).

Move areas of the 93<sup>rd</sup> House District from Rock Chapel Road (RL) to Stoneview Elem (SL).

Move areas of the City of Atlanta from LaVista Road (LB) to Emory Road (ER).

Move areas of the City of Tucker from Livsey Elem (LV) to Midvale Elem (MH) and Tucker Library (TF).

Move areas of the City of Decatur from Scott (SB) to Clairemont East (CV).
