DEKALB PEACHTREE AIRPORT NORTH TERMINAL LEASE AREA NA

All that tract of land lying and being in Land Lot 279 of the 18th District, DeKalb County, Georgia on the DeKalb Peachtree Airport Property, and being more particularly described as follows:
