Recommendation is to continue to process as a one (1) year sole source for standardized equipment, parts, and related system components. Teledyne ISCO is the sole manufacturer of the 2100 Series ISCO Brand flow monitor and its various compatible equipment, parts, and related system components. The market does contain other flow monitors, batteries, and rain gauges with a variety of new technologies used in determining the flow of water and wastewater but DeKalb County Watershed Management (DWM) has built its hydraulic monitoring and sewer flow monitoring programs around monitors supplied by Teledyne ISCO. At this stage, it would not be efficient or effective for the County to introduce new monitors into their existing system and program. The existing system and program assists in completing water meter installations by providing the much needed flow reviews as well as assistance in the hydraulic modeling and sewer monitoring programs occurring under the Consent Decree Program.
