• NOTE: Mandatory Pre-Bid and Site visit; which five (5) bids were expected due to the Mandatory LSBE meetings attendance and mandatory site visit attendance. The two vendors that met both mandatory meeting requirements and did not bid offered the following reasons. (1) ABM Landscape – did not bid because after listening to others at the Pre-Bid they decided that there were too many "unknowns" for them to try to pull together a bid (such as how long before the 'greens' would be ready, who would maintain them until the maintenance contract was awarded, how much sand would be required, etc.); (2) Cornerstone Golf Partners – did not bid because (a) they did not like the way the ITB was written; (b) they did not like the invoicing/payment structure for cutting the greens; and (c) because they felt the irrigation system would still be a problem.
