Payment of this sum is also conditioned on obtaining any Court approval required by law to finalize the settlement. To resolve these lawsuits, the County will terminate Contract No. 12-902437 for convenience; will pay the total sum of \$525,000.00 to Desmear and its counsel; and will dismiss with prejudice its counterclaims against Desmear in Civil Action No. 15CV5780, in return for and conditioned on Desmear's dismissal with prejudice of its two above-referenced lawsuits and Desmear's execution of a settlement agreement with waiver and release of claims that is acceptable to the County Attorney, which will also include a waiver of DeKalb County's claims against Desmear.
