5. Need and Purpose:

The County has executed SPLOST resurfacing contracts that total approximately 100 miles of the 300 miles of roadway to be resurfaced in the SPLOST Program. This contract modification will aid in the County's efforts to fix potholes on roads to be resurfaced under SPLOST. The County will use existing on-call contracts with the following vendors for advance patching: A&S Paving, contract # 1118591, ITB 17-100898, good through June 11, 2019, \$2,739,737; Greenway One, contract #1115899, ITB 17-100898, good through June 11, 2019, \$2,523,106; and HEH Paving, contract #1118593, ITB 17-100898, good through June 11, 2019, \$5,042,214. These contracts are annual contracts with remaining 2 options to renew. This request is for \$500,000 from Transportation Category 1A in the SPLOST Program.
