Justification:

This RFP provides for the continuation of the airport's Noise & Operations Management System and replaces the airport's aging noise monitors. Harris Corporation received the highest score from the evaluation committee, and thus the Airport has elected to recommend Harris Corporation as the winner.

The base amount of Harris's proposal is \$376,388. Four (4) optional items were selected by airport management for a grand total of \$521,565 over five (5) years.
